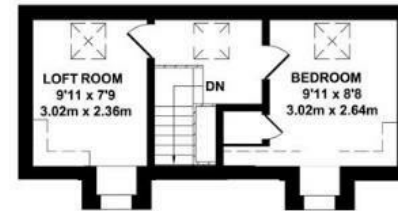

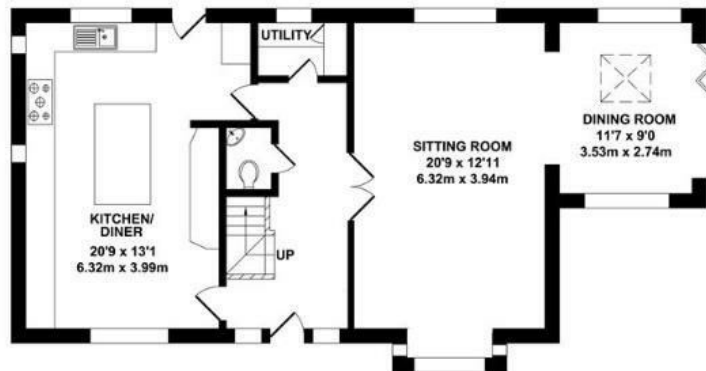

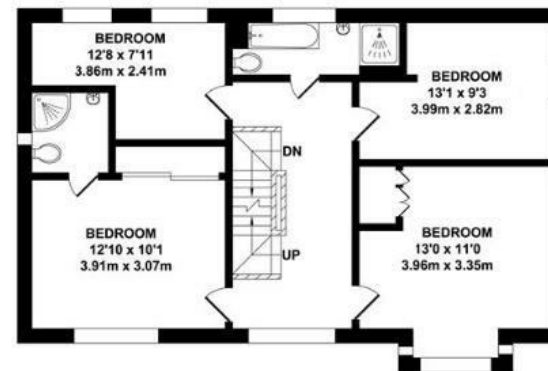




SECOND FLOOR
