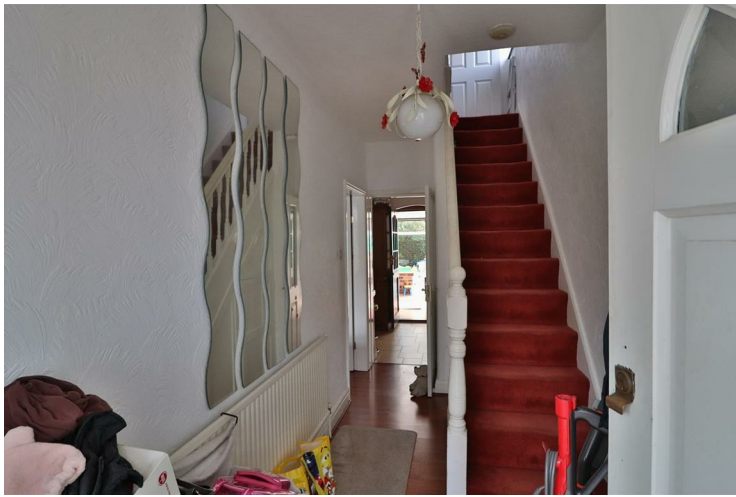

ENTRANCE PORCH



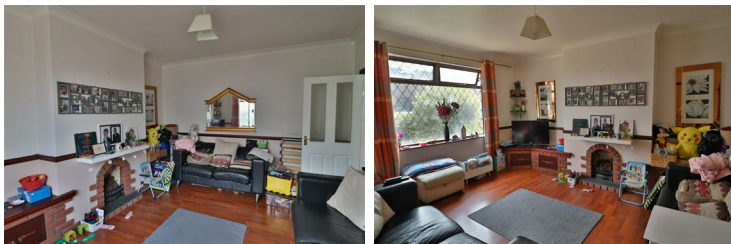
Accessed via a Upvc double glazed door, Upvc double glazed windows.

ENTRANCE HALLWAY



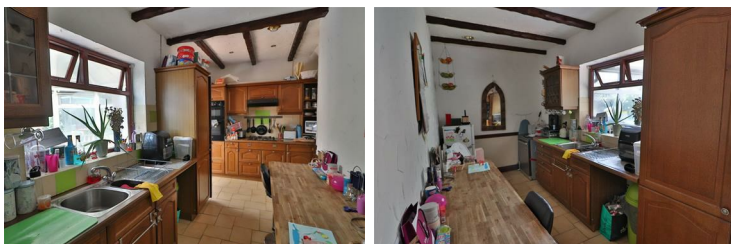
With stairs leading to the first floor accommodation, wood laminate flooring under stairs storage cupboard.

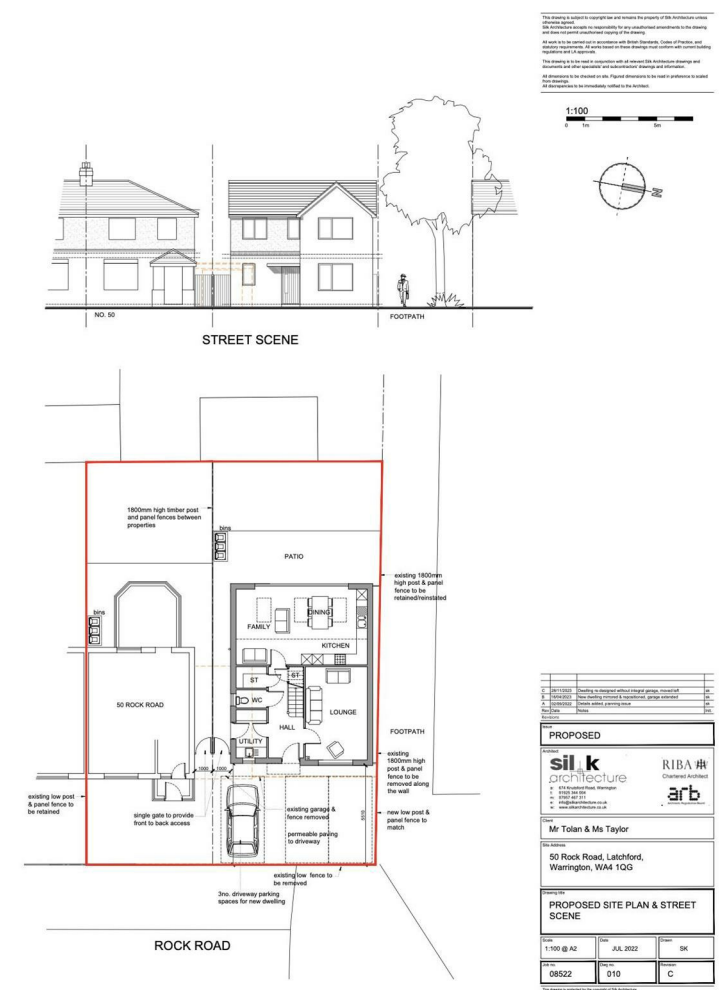

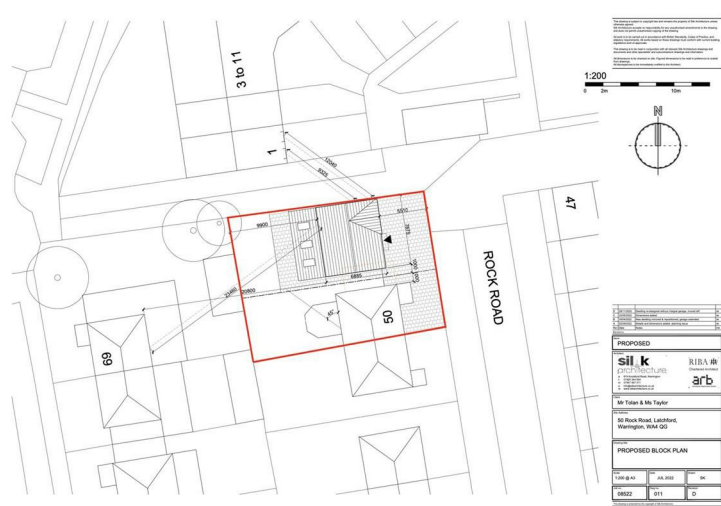

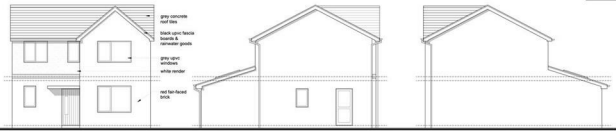

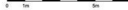

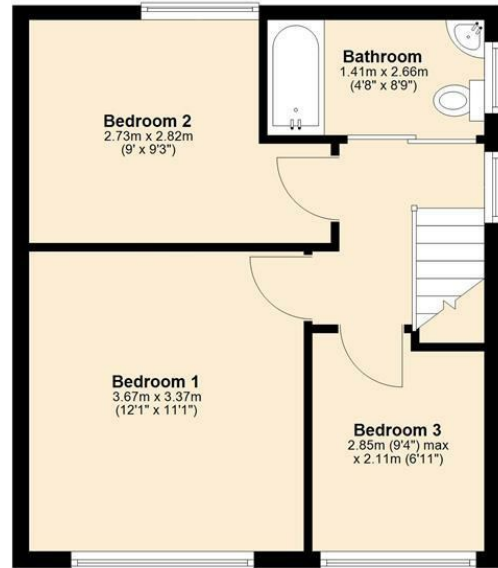
Ground Floor

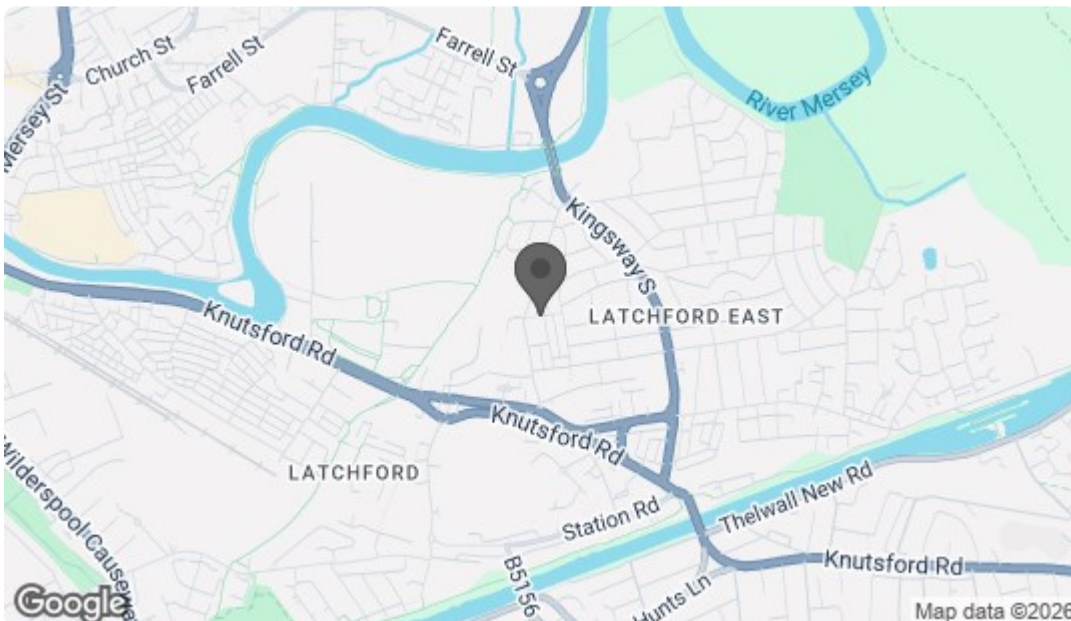


First Floor
