

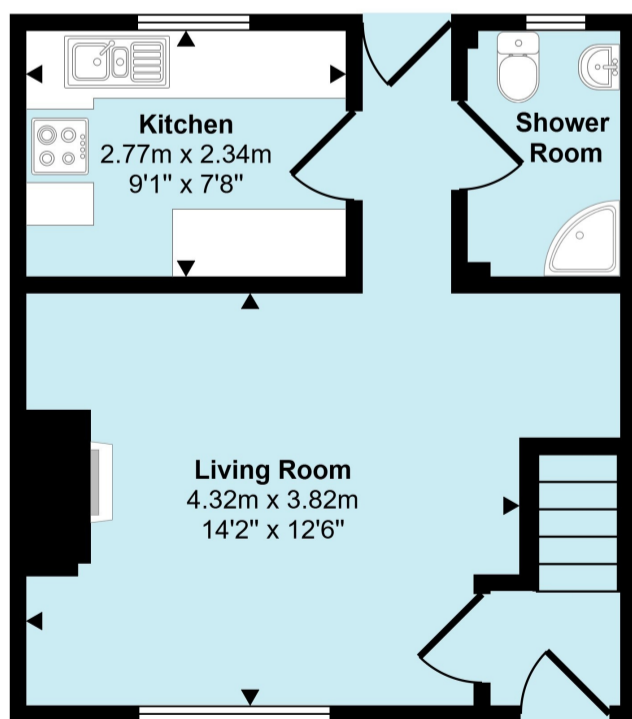

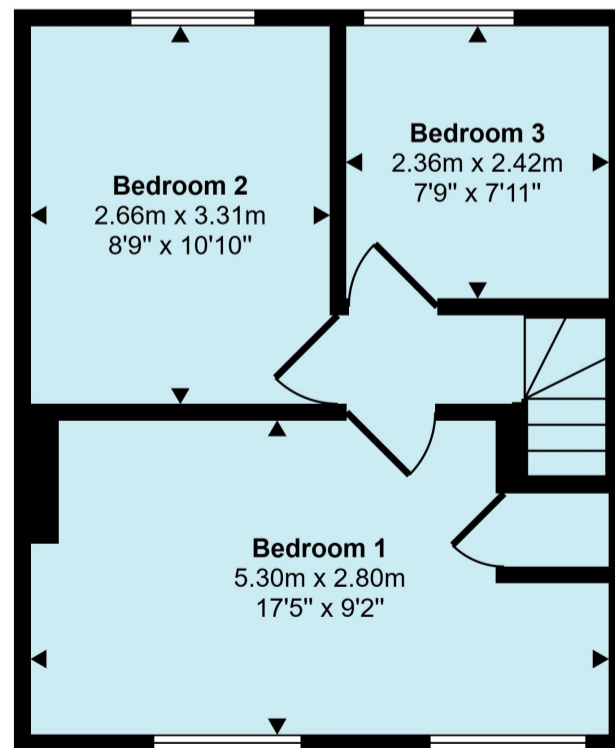

Description

Berrydale Avenue is a three bedroom terrace property which has been updated since our vendors purchased the house in 2017.

THE PROPERTY:

The accommodation comprises an entrance hall, a living room, a kitchen with a range of wall and base units, with space for a cooker, washing machine and a tumble dryer and a bathroom which has been refitted with a new shower suite and panelled walls.

To the first floor are three good size bedrooms, with all ceilings having been replaced and walls plastered in the property with new carpets and vinyl throughout.

To the rear of the house is a low maintenance garden which has been designed in sections to make the most of the evening sun with a rear access gate and a brick outhouse.

To the exterior the roof felt, fascias and guttering have all been replaced and double glazed windows have been installed.

A viewing of this property is highly recommended to see the work that has been completed since the vendors have owned it.

LOCATION:

The property is situated on the favoured west side of Bridgwater, with junior and senior schools of high repute close to hand. Bridgwater town centre is a level walk away offering a full range of facilities including retail, educational and leisure amenities. There are regular bus services to Taunton, Weston-super-Mare and Burnham-on-Sea together with a daily coach service to London Hammersmith. Access to the M5 motorway can be gained via junctions 23 and 24 whilst the town also provides a main line railway link.
