



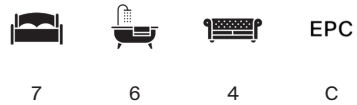

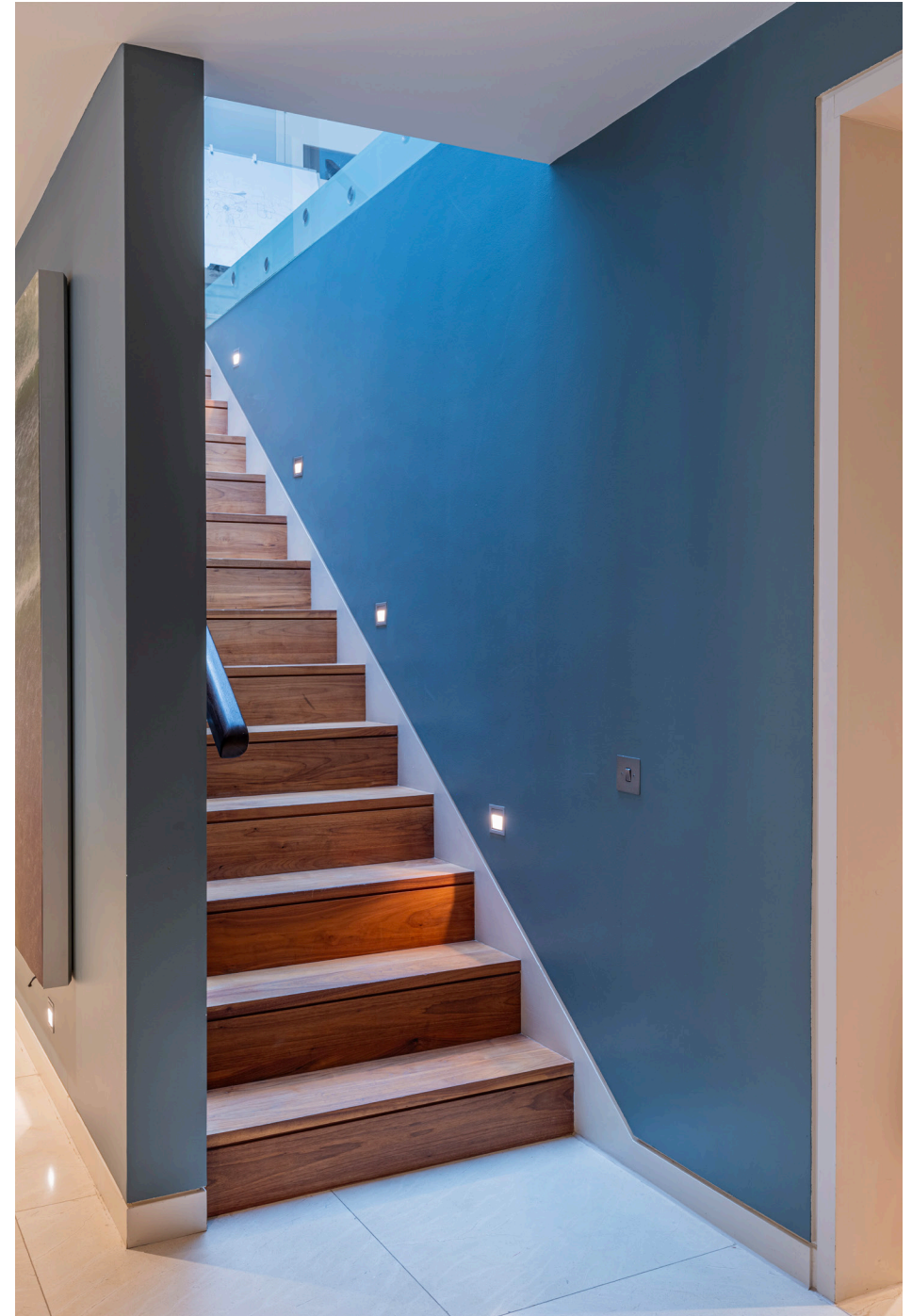

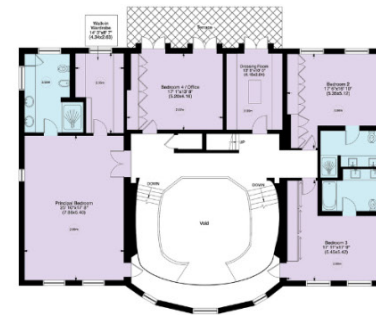








Second Floor
