A bright entrance hall with parquet-style flooring, oak doors and a striking open-tread staircase leads into the magnificent open-plan kitchen, dining and living area. Designed for modern family life and entertaining, this superb space features extensive contemporary cabinetry, integrated appliances, a substantial central island and an inviting lounge area with a feature log burner. Rooflights and French doors introduce an abundance of natural light while creating a seamless connection with the garden. Two generous double bedrooms are positioned on the ground floor, one of which benefits from French doors opening onto the rear garden. Both are served by a stylish shower room featuring contemporary sanitaryware, fitted storage and modern floor-to-ceiling tiling.

The first floor is dedicated to an impressive principal suite, complete with rooflights, extensive eaves storage and a luxurious en-suite bathroom featuring a freestanding bath and contemporary glass wash basin.

Outside, the substantial gravelled frontage provides exceptional off-road parking for numerous vehicles, with space for a caravan or motorhome. A timber-built carport offers covered parking, while solar panels are fitted across the carport and main residence. The private, low-maintenance rear garden is designed for outdoor living, with extensive raised decking, retractable sun awnings and a covered barbecue area. A substantial timber garden room offers excellent potential as a home office, gym, games room or entertaining space.

Conveniently positioned for Great Wyrley's shops, schools and amenities, the property also offers excellent access to Landywood railway station and major road links. 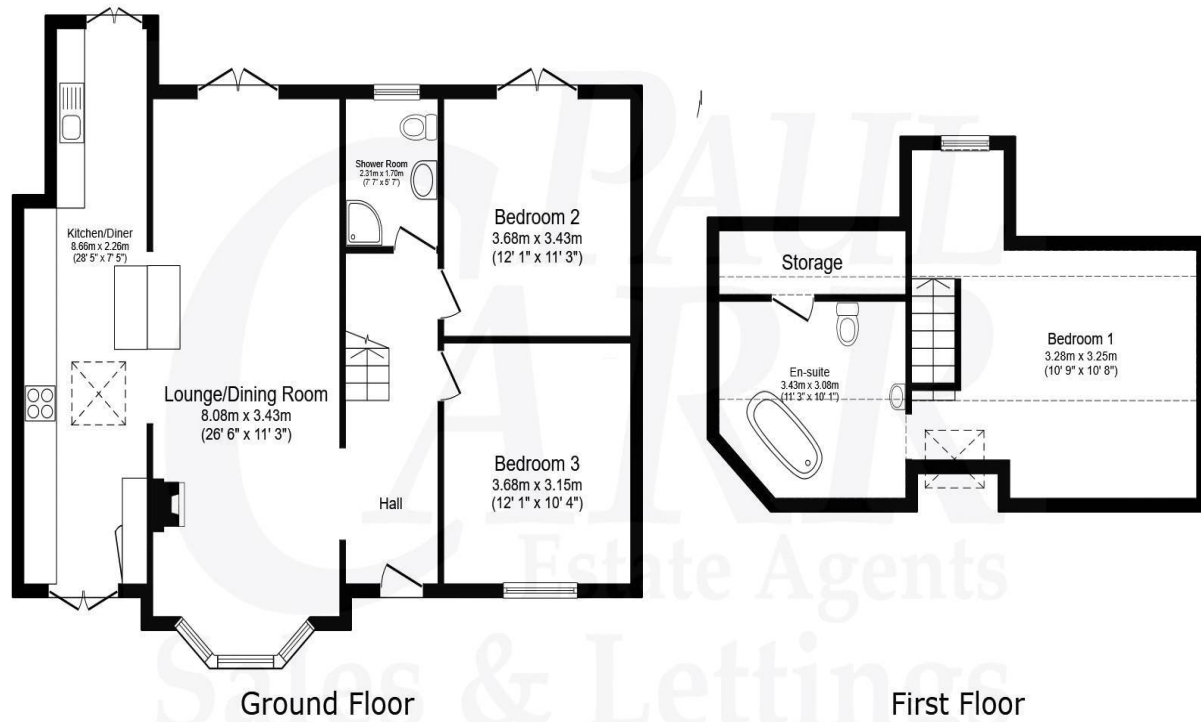




Floor Plan
