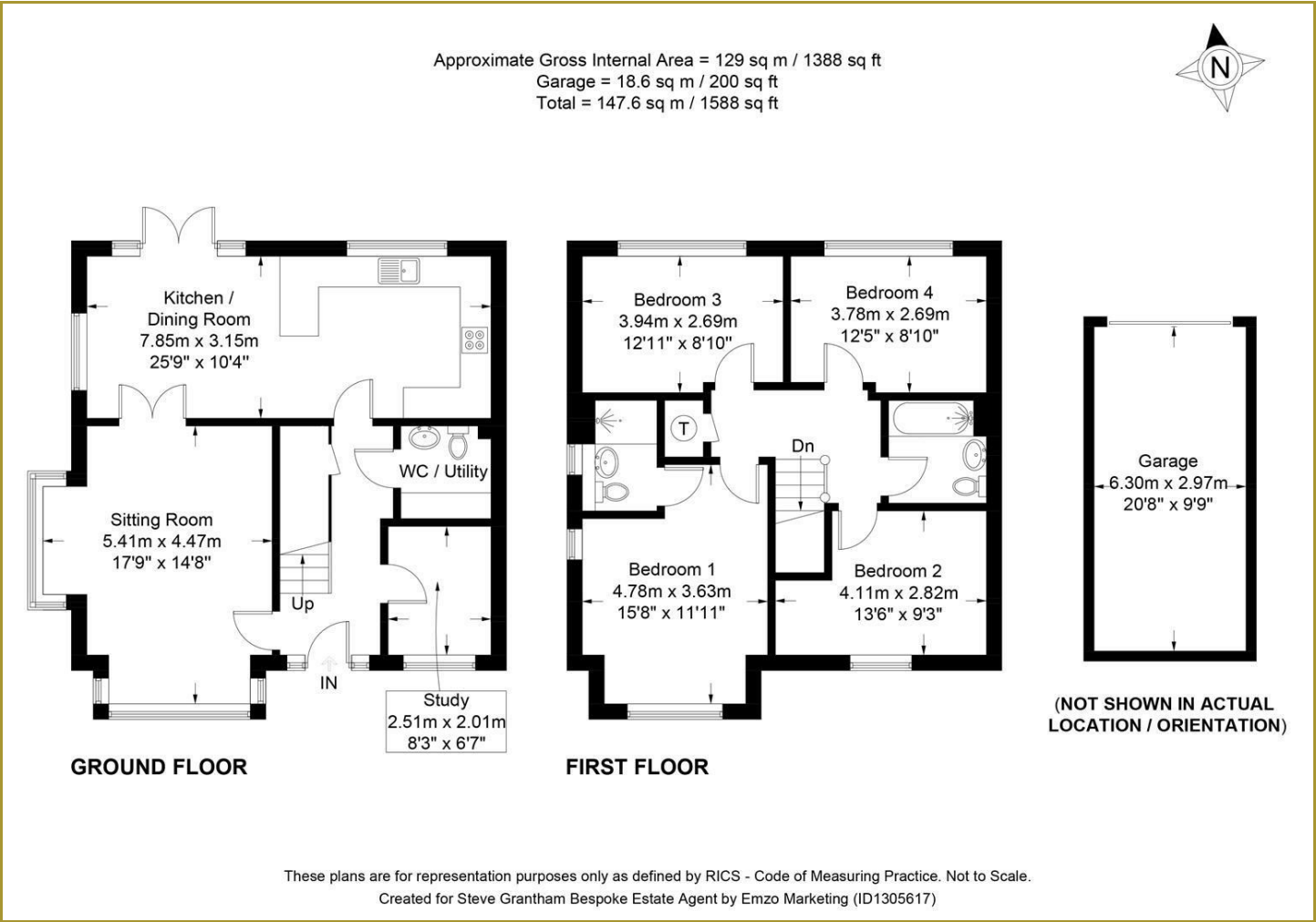

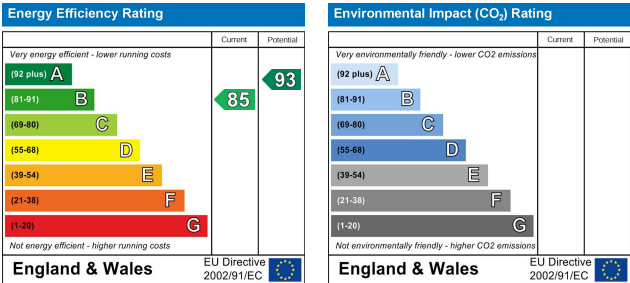
Floor Plans
