



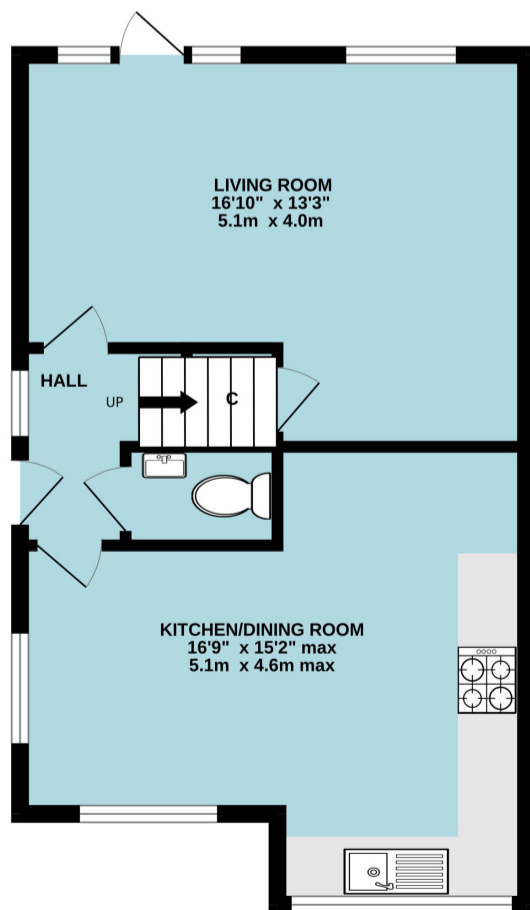

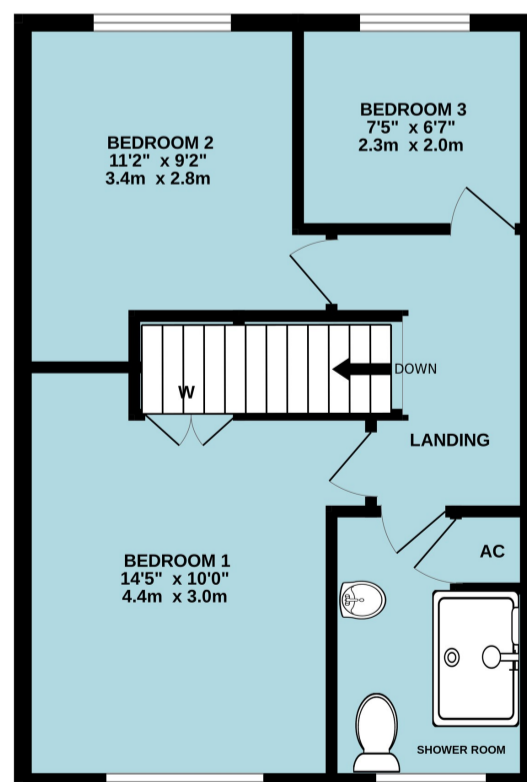

## LOCATION:

Situated in a cul-de-sac position on the Quantock View development, the southern fringe of the market town centre of Bridgwater. North Petherton is approximately 1.5 miles away offering a range of shops, infant and junior school plus further amenities. Bridgwater town centre approximately 1.5 miles away and offers a full range of amenities including retail, leisure and educational facilities. Main line links are available at Bridgwater Railway Station. There are regular bus services to Taunton, Weston-super-Mare and Burnham-on-Sea together with a daily coach service to London Hammersmith from Bridgwater Bus station.
