The Property
 Trezunger is a striking castellated residence dating back to the 1880s situated at the mouth of the River Fowey. Trezunger was built as 2 semi-detached houses. The South-West 'Trez' side nearest the castle is on the market for the first time in 40 years.

It is a much loved home and has been renovated over the years by the current owner. Rich in period charm, the property retains original fireplaces, wooden floors, coving and a beautiful balustrade staircase.

The accommodation is arranged as two apartments:

Apartment 1 – Ground Floor
 A spacious one/two-bedroom apartment with elegant bay windows, sea views, large master bedroom and smaller second bedroom/office space, sitting room with fireplace suitable for a log burner, dining room, kitchen, utility room and a conservatory opening onto the gardens.

Apartment 2 – First & Second Floors
 A superb four/five-bedroom duplex apartment featuring a stunning living room with parquet flooring, wood burner and balcony overlooking the harbour. The kitchen/dining room enjoys magnificent coastal views, complete with gas AGA, complemented by four generous bedrooms including a principal suite with ensuite bathroom and captivating views over the sea and St Catherine’s castle.

Outside
 Beautiful, terraced gardens cascade towards the waterfront, creating exceptional outdoor spaces to relax and enjoy the ever-changing harbour scenery. A lower “gin terrace” provides the perfect vantage point for watching sailing and regatta events.

An outhouse with electricity and plumbing offers excellent utility and storage options. There is a raised accessway in front of neighbouring properties, to the front of number 20, useful for loading and unloading a vehicle.
