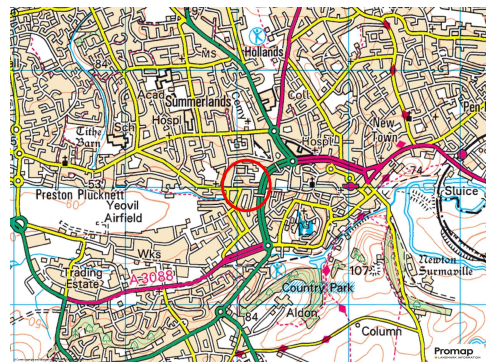
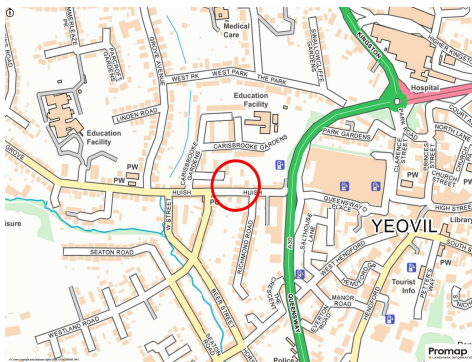
The flat is approached to the rear of the block via an Iron staircase, that leads up to the Communal door. .
