The layout briefly comprises a reception hall, sitting room, dining room, kitchen, walk-in storage cupboard with guest cloakroom off, first-floor landing, three bedrooms and a family bathroom.

Externally, the property benefits from a wide frontage with ample off-road parking. To the rear, there is the added advantage of a garage and carport accessed from behind the property, together with an enclosed rear garden which has been predominantly paved for ease of maintenance.

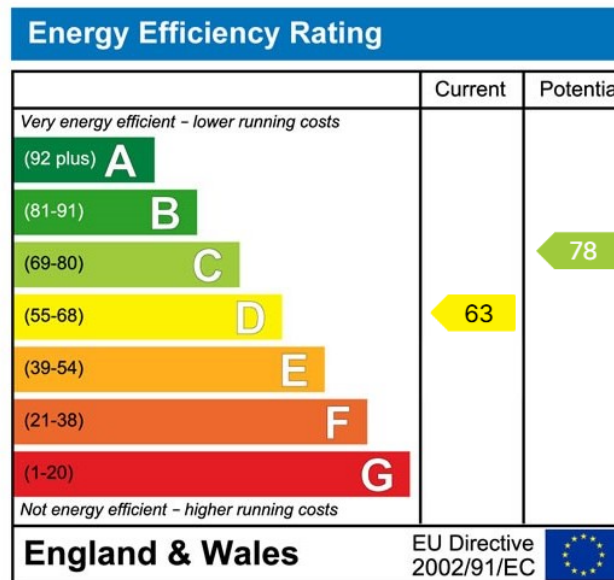
