

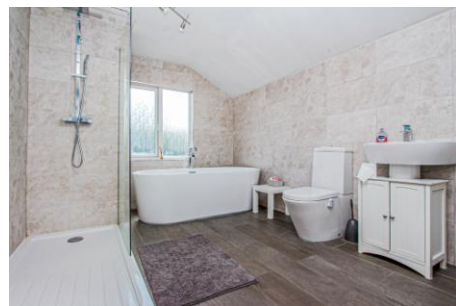
Scarborough Street, Irthlingborough

A spacious and well presented bay fronted three bed roomed mid terrace property situated close to Irthlingborough's High Street shops and infant/junior school featuring a 26ft lounge/dining room, a refitted four piece first floor bathroom suite, modern kitchen, uPVC double glazing and gas radiator central heating. The accommodation briefly comprises entrance hall, lounge/dining room, kitchen, three bedrooms, bathroom, outbuilding, gardens to front and rear.

Stairs rising to first floor landing, tiled flooring radiator, door to:

Bay window to front aspect, window seat, coving to ceiling, radiator, laminate flooring, electric fire, wooden mantel, TV and telephone point, through to:

Dining Area

Window to rear aspect, radiator, laminate flooring, coving to ceiling, door to:

Kitchen

12' 11" x 8' 11" (3.94m x 2.72m)(This measurement includes the area occupied by the kitchen units.)

Fitted to comprise ceramic one and a half bowl single drainer sink unit with cupboard under, a range of base and eye level units providing work surfaces, plumbing for washing machine, plumbing for dishwasher, space for fridge/freezer, freestanding range cooker, tiled splash backs, tiled floor, coving to ceiling, under stairs storage cupboard, radiator, door and window to side aspect.

Refitted to comprise low flush W.C, pedestal wash hand basin, double shower cubicle, freestanding bath with chrome mixer taps, tiled splash backs, radiator, window to rear aspect, cupboard housing wall mounted gas boiler serving domestic hot water and central heating systems, loft access.

Front - Small foregarden enclosed by low brick walling.

Rear - Paved courtyard area, outbuilding measuring approx. 11' 2" x 9' 2" (power and light connected), shared gated rear pedestrian access, artificial lawn with deck, enclosed by wooden panelled fencing.
