THE PROPERTY:

The accommodation comprises an entrance hall with stairs to the first floor. There is a living room which has a bay window to the front, a dining room and a kitchen having a range of wall and base units and space for a cooker, tall fridge/freezer and a washing machine. Also on this floor is a cloakroom.

To the first floor are three bedrooms and a shower room.

Outside – The path leads to the front door and the garden to the rear is a blank canvas and would make a perfect project for any gardener to maximise its potential. There is also the benefit of two off-road parking spaces at the rear.
