The property is considered ideal for large family occupation. It is in a particularly favoured position with far reaching views over the Country Park to the English channel beyond. The well presented accommodation comprises reception hallway with triple aspect living room, cloakroom, large landing/snug with double doors opening out to a roof terrace, stairs then rise to the bedroom accommodation which is on the first floor. There are four good sized bedrooms, one with an en-suite shower room and also a family bathroom, from the ground floor, stairs descend to a lower ground floor, kitchen/breakfast room with adjoining utility room and access to useful under house storage. There is a dining room and further family/games room adjoining. The rear garden is accessed both from the dining room and the kitchen/breakfast room and a terraced area with a gently sloping lawn bordered by mature hedging and trees. There is large hardstanding to the front that provides off road parking for several cars and access to the integral garage, steps then rise to the front door. Saltrock is located in the much sought after coastal village of Fairlight, situated within the High Weald Area of Outstanding Natural Beauty. There is a general store/post office and active community hall within the village and a newly opened public house, whilst extensive shopping, primary and secondary school, sporting and recreational amenities can be found in the nearby Historic Coastal Town of Hastings and Rye

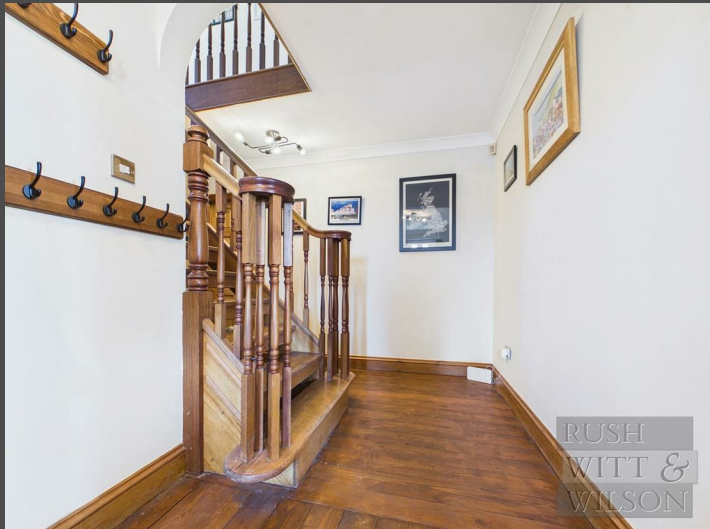
