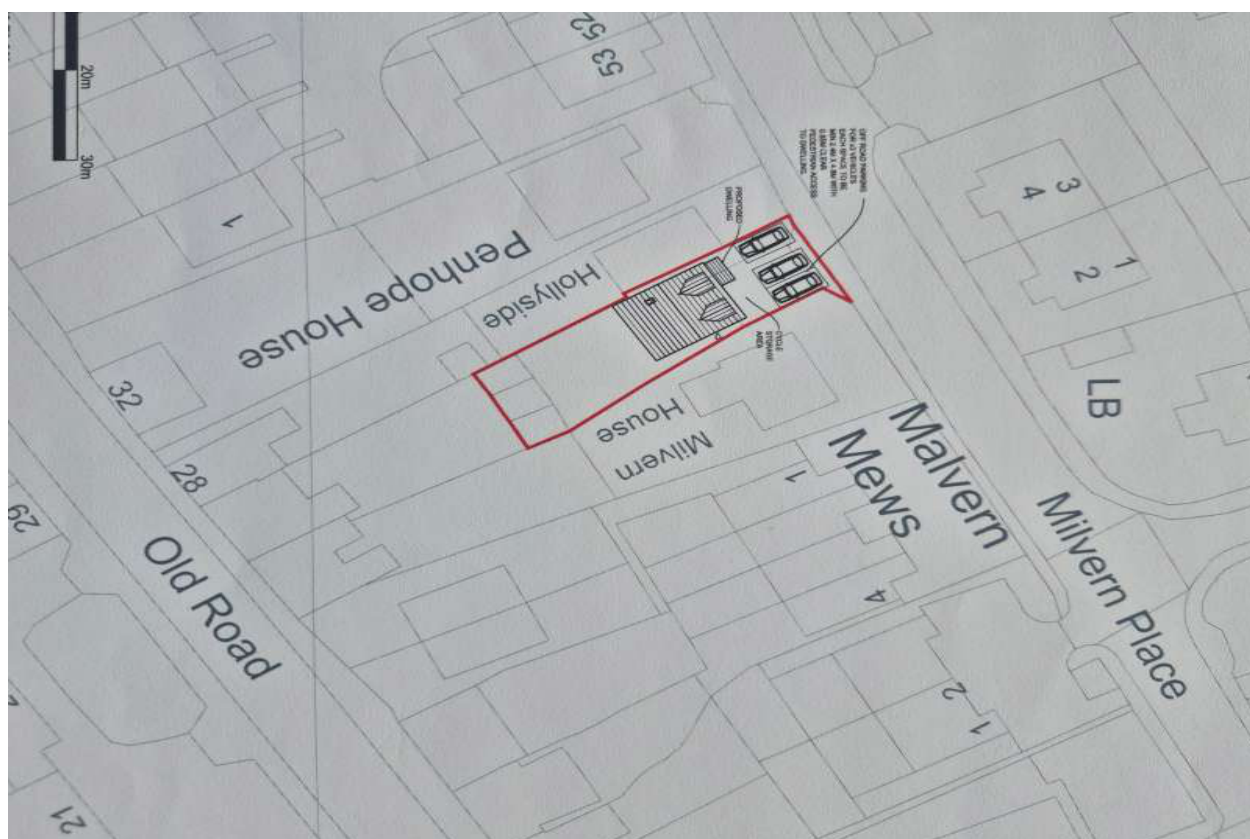

LOCATION

The plot joins no-through Milvern Road which is just a short walk to the supermarket and farm shop on Tenbury Road. A passageway, to the west of the community building, leads to the town centre and all its amenities. The two schools are also within walking distance. Approx. 13 miles Hereford and Worcester, 15 the M5.

THE BUILDING PLOT

This has good frontage to Milvern Road and, from its elevated position, slopes gently to the south resulting in pleasant views. To the west and south boundaries, there is lap fencing and to the east side a solid block wall and hedge.
