INTRODUCTION

A first floor flat set in this attractive building, located on Queen Mother Square and is accessed to the rear of the building by lift and staircase to all floors. Built in 2011 the property offers well-proportioned and beautifully presented accommodation.

THE PROPERTY

There are three entrances into the building, one providing a lift to all floors and the other two with stairs to all floors. The first floor flat comprises an entrance hallway, a kitchen/breakfast room with a range of floor and wall-mounted units with under pelmet lighting and worktops over, Belfast sink, integrated electric oven and hob with extractor fan above. Integrated eye level microwave, dishwasher, washer/dryer, and fridge/freezer. The kitchen offers space to include a breakfast table.

The splendid sitting/dining room expands over the entrance which forms part of the attractive façade of the building, enjoys views over Queen Mother Square.

There are two double bedrooms both with fitted wardrobes, one having a well appointed, fully tiled en-suite shower room. The family bathroom has a contemporary fitted white suite with bath and shower over.

OUTSIDE

Access to the car park with two allocated parking spaces, bike storage and recycling store located to the rear of the building.

SITUATION

The property is situated on Queen Mother Square, which provides a good range of amenities including Waitrose, a public house, butcher, Luxury Monart Spa, gallery, coffee houses, opticians and restaurants. Across the Poundbury development there are a variety of boutiques, a post office, veterinary practice, dental surgeries, doctors' surgeries, and Damers First School, along with a number of specialist outlets.
