## 1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

<b>Description</b>	The subjects comprise a two storey mid terraced house.
<b>Accommodation</b>	On Ground Floor: Entrance Hallway, Living Room/Dining and Kitchen. On First Floor: Landing, two Bedrooms and Shower Room with WC.
<b>Gross Internal Floor Area (m<sup>2</sup>)</b>	82 sq m or thereby
<b>Neighbourhood and Location</b>	The subjects are located in an established residential area of Buckhaven, originally constructed for public sector letting purposes. Surrounding properties are of a similar style and character. Local shopping and public transport amenities are available in the general area.
<b>Age (Year Built)</b>	The subjects are thought to have been constructed around 1970.
<b>Weather</b>	Overcast and wet.
<b>Chimney Stacks</b>	None.

<b>Roofing including Roof Space</b>	<p>The roof is timber pitched and overlaid with tiles.</p> <p>Access to the roof space is via a ceiling hatch with associated drop down ladder located off the landing. The roof frame is part floored with insulation materials laid between and over ceiling joists and accommodates a galvanised cold water storage tank.</p> <p>Sloping roofs were visually inspected with the aid of binoculars where appropriate.</p> <p>Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.</p>
<b>Rainwater Fittings</b>	<p>Rainwater units are run in PVC.</p> <p>Visually inspected with the aid of binoculars where appropriate.</p>
<b>Main Walls</b>	<p>The main walls are of traditional cavity brick/block construction with a mixture of pointed facing brick and render finishes.</p> <p>Visually inspected with the aid of binoculars where appropriate.</p> <p>Foundations and concealed parts were not exposed or inspected.</p>
<b>Windows, External Doors and Joinery</b>	<p>Window units are of replacement uPVC double glazed type. The property is accessed to front and rear by replacement uPVC part double glazed doors. There are some uPVC eaves areas.</p> <p>Internal and external doors were opened and closed where keys were available.</p> <p>Random windows were opened and closed where possible.</p> <p>Doors and windows were not forced open.</p>
<b>External Decorations</b>	<p>External decorations are of painted and uPVC finishes.</p> <p>Visually inspected.</p>

<b>Garages and Permanent Outbuildings</b>	<p>There is a rendered brick outbuilding within the rear garden, this beneath a low single pitched and felted roof. This is accessed by a timber door.</p> <p>Visually inspected.</p>

<b>Outside Areas and Boundaries</b>	<p>There are private front and rear gardens, boundaries being formed by a mixture of brick walling and timber fencing. There is on street car parking to the front of the property. Rear garden grounds are laid out with a mixture of chips and paving.</p> <p>Visually inspected.</p>

<b>Ceilings</b>	<p>Ceilings are plasterboard lined.</p> <p>Visually inspected from floor level.</p>

<b>Internal Walls</b>	<p>Internal walls are plastered and plasterboard lined.</p> <p>Visually inspected from floor level.</p> <p>Using a moisture meter, walls were randomly tested for dampness where considered appropriate.</p>

<b>Floors Including Sub-Floors</b>	<p>Flooring throughout is of suspended timber construction. There is limited sub-floor access via sections of removable flooring within a kitchen cupboard. The inspection was significantly restricted due to the presence of servicing and lack of clearance.</p> <p>Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.</p> <p>Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.</p> <p>Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.</p>

<b>Internal Joinery and Kitchen Fittings</b>	<p>Internal joinery is of timber with timber internal pass doors, some incorporating glazed inserts, timber door facings and skirtings. The kitchen is fitted with some floor and wall mounted storage units. There is a timber framed staircase.</p> <p>Built-in cupboards were looked into but no stored items were moved.</p> <p>Kitchen units were visually inspected excluding appliances.</p>

<b>Chimney Breasts and Fireplaces</b>	<p>There is no chimney breast however there is a decorative fireplace surround within the living room.</p>

<b>Internal Decorations</b>	<p>Internal decoration is a mixture of papered, painted, textured and tiled finishes.</p> <p>Visually inspected.</p>

<b>Cellars</b>	<p>Not applicable.</p>

<b>Electricity</b>	<p>Mains supply. The electrical switch gear is located within a kitchen cupboard.</p> <p>Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p>

<b>Gas</b>	<p>Mains supply. The gas meter is located within a kitchen cupboard.</p> <p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p>

<b>Water, Plumbing and Bathroom Fittings</b>	<p>Mains water supply. Where seen, plumber work appears to be formed in a mixture of copper and PVC materials. The stopcock is located within a kitchen cupboard. The cold water rising main was unseen. There is a standard kitchen sink unit. The shower room comprises a three piece suite. There is as galvanised cold water storage tank within the roof space.</p> <p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.</p>

<b>Heating and Hot Water</b>	<p>There is a wall mounted gas fired combination central heating boiler located within a kitchen cupboard. This supplies steel panelled radiators and also provides domestic hot water. There is a heated towel rail within the shower room.</p> <p>Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.</p>
<b>Drainage</b>	<p>All foul and surface water drainage is assumed to be connected to the main public sewer.</p> <p>Drainage covers etc were not lifted.</p> <p>Neither drains nor drainage systems were tested.</p>
<b>Fire, Smoke and Burglar Alarms</b>	<p>New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.</p>



<b>Additional limits to Inspection</b>	<p>It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.</p> <p>No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.</p> <p>A restricted inspection was possible only of the roof space due to accessibility, insulation materials and/or storage items.</p> <p>Our inspection was restricted to the exposed and accessible surface fabric.</p> <p>It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.</p> <p>Due to fitted carpets and floor coverings no detailed inspection was possible of the floor timbers and accordingly we cannot guarantee their soundness or otherwise.</p> <p>Restricted inspection in cupboards due to storage items.</p> <p>At the time of inspection the subjects were unoccupied, generally unfurnished and floors were mainly covered. The services were not tested.</p> <p>The inspection of the sub-floor area was significantly restricted and limited to a small area beneath a kitchen cupboard.</p> <p>A restricted inspection was possible only of the roof from ground level.</p>

<b>Notes</b>	<p>There is an element of wear to roof coverings including some lifted tiles. There are some moss coverings. There is some localised moisture staining to sarking materials within the roof space.</p> <p>The roof covering is now of an age where ongoing and regular maintenance will be required and it would be prudent to seek the advice of a roofing contractor to comment on its current condition and expected lifespan.</p> <p>Extractor fan ductwork from the shower room is disconnected from the outside air and repairs will be required.</p>

<b>Notes</b>	At the time of our inspection there was no evidence of damp staining/water staining on wall surfaces which would indicate leakage. It should be noted that it was not raining heavily at the time of our inspection.

<b>Notes</b>	The main outer walls of the property generally appeared in fair order consistent with age however there is weathering to base course brickwork and localised sections of cracked render. There is some cracking/deterioration to concrete window sills. The need for ongoing maintenance/repair should therefore be anticipated.


	<b>Windows, External Doors and Joinery</b>

Notes	<p>There is a suspected failed double glazed unit seal within a front bedroom causing condensation to form between the panes. There is some wear to window sealant.</p> <p>Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/ repair will be required as part of an ongoing maintenance programme.</p>

## 4. Valuation and Conveyance Issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

### Matters for a Solicitor or Licensed Conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

We assume that the carriageways etc., ex adverso the subjects are the responsibility of the Local Authority.

There is an apparent communal bin collection corridor or similar to the rear of the property and its neighbours. The conveyancer can check whether all legal arrangements are adequate.

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include the installation of replacement double glazed window units and doors and the apparent removal of a wall within the living room/dining room..

### Estimated Reinstatement Cost for Insurance Purposes

£280,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than **£280,000 (TWO HUNDRED AND EIGHTY THOUSAND POUNDS STERLING)**.

**Valuation and Market Comments****£95,000**

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £95,000 (NINETY-FIVE THOUSAND POUNDS STERLING).

## TERMS AND CONDITIONS OF SINGLE SURVEY

### GENERAL

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

#### 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. The Report is prepared with the skill and care reasonably to be expected of a competent residential surveyor who is a member of the Royal Institution of Chartered Surveyors.

The Report is addressed to the Seller and is prepared in the expectation that it (or a complete copy) along with these Terms and Conditions (or a complete copy) would be (or, as the case might be, would have been) disclosed and delivered to:

- the Seller;
- any person(s) noting an interest in purchasing the Property from the Seller;
- any person(s) who make(s) (or on whose behalf is made) an offer to purchase the Property, whether or not that offer is accepted by the Seller;
- the Purchaser; and
- the professional advisors of any of these.

The Surveyors acknowledge that their duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

## DESCRIPTION OF THE REPORT

### 2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

### 2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, **visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.**

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the Report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Report of Property that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a register of asbestos and effective management plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

### 2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:

#### 2.3.1 Category 3:

Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the Property or cause a safety hazard. Estimates for repairs or replacement are needed now.

#### 2.3.2 Category 2:

Repairs or replacement requiring future attention, but estimates are still advised.

#### 2.3.3 Category 1:

No immediate action or repair is needed.

### WARNING:

If left unattended, even for a relatively short period, Category 2 repairs can rapidly develop into more serious Category 3 repairs. The existence of Category 2 or Category 3 repairs may have an adverse effect on marketability, value and the sale price ultimately achieved for the Property. ## 2.6 Energy Report

A section is included that makes provision for an Energy Report, relative to the Property. The Surveyor will collect physical data from the Property and provide such data in a format required by an accredited energy company. The Surveyor cannot of course accept liability for any advice given by the energy company.

## 2.7 Valuation & Conveyancer Issues

The last section of the Report contains matters considered relevant to the conveyancer (solicitor). It also contains the Surveyor's opinion both of the market value of the Property and of the re-instatement cost, as defined below.

The subjects are located in an established residential area of Buckhaven, originally constructed for public sector letting purposes. Surrounding properties are of a similar style and character. Local shopping and public transport amenities are available in the general area.

The subjects generally appear to have been maintained in a fair condition having regard to age, type and construction but would benefit from a degree of upgrading internally. The need for ongoing maintenance/repair should be anticipated to the external building fabric.

There is an apparent communal bin collection corridor or similar to the rear of the property and its neighbours. The conveyancer can check whether all legal arrangements are adequate.

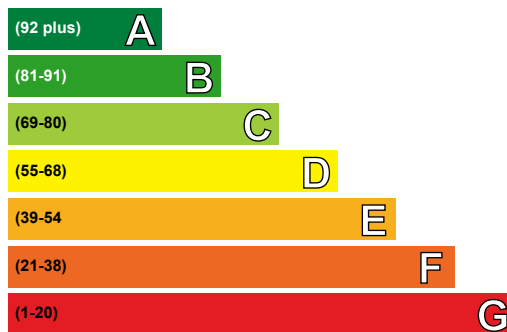

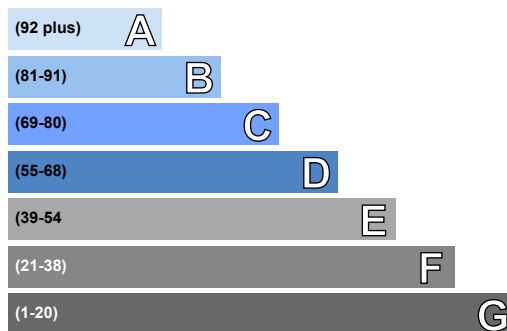

## The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. ### 1 Cavity wall insulation

Cavity wall insulation, to fill the gap between the inner and outer layers of external walls with an insulating material, reduces heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. The insulation material is pumped into the gap through small holes that are drilled into the outer walls, and the holes are made good afterwards. As specialist machinery is used to fill the cavity, a professional installation company should carry out this work, and they should carry out a thorough survey before commencing work to ensure that this type of insulation is suitable for this home and its exposure. They should also provide a guarantee for the work and handle any building standards issues. Further information about cavity wall insulation and details of local installers can be obtained from the National Insulation Association ([www.nationalinsulationassociation.org.uk](http://www.nationalinsulationassociation.org.uk)).

### 2 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

### 3 Heating controls (room thermostat)

The heating system should have a room thermostat to enable the boiler to switch off when no heat is required. A competent heating engineer should be asked to do this work. Insist that the thermostat switches off the boiler as well as the pump and that the thermostatic radiator valve is removed from any radiator in the same room as the thermostat. Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

### 4 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent).
