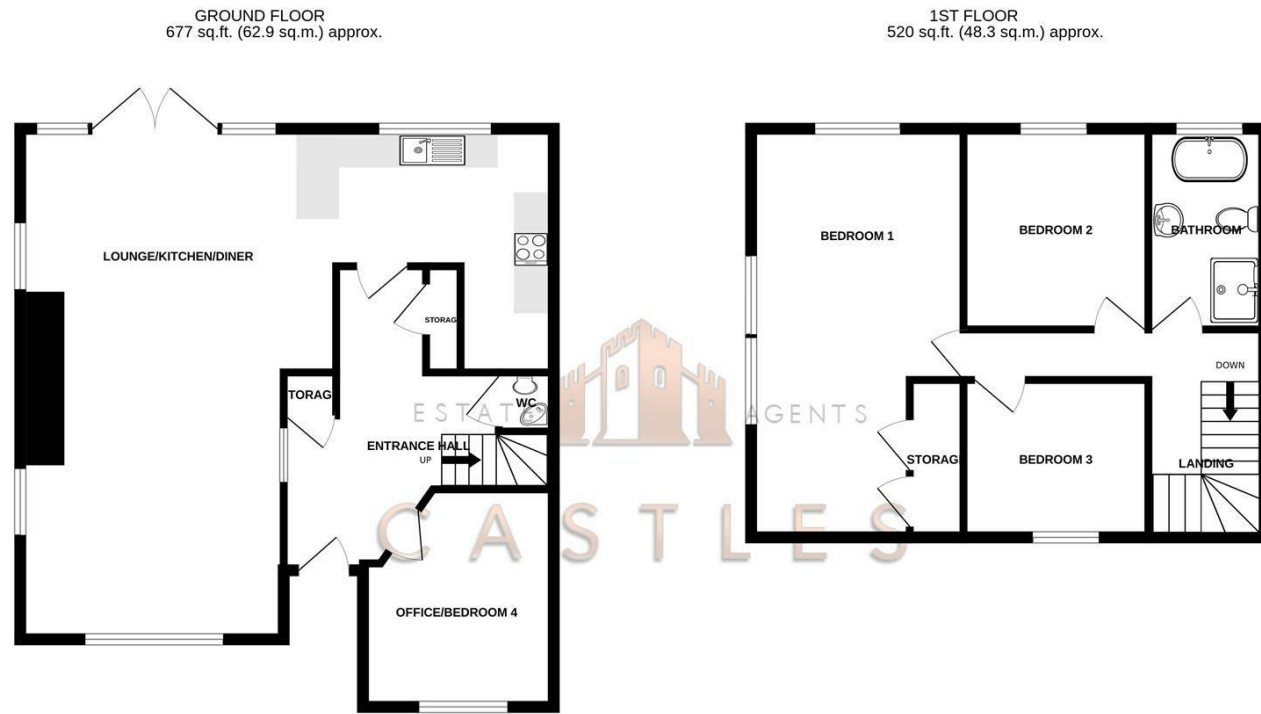


Floor Plan

We are pleased to welcome to the market this exceptional four bedroom detached bungalow with solent views and plenty of off road parking situated on a large corner plot in Dore Avenue, Portchester.

The current owners have transformed this home to a high standard throughout and the ground floor consists of a large open plan kitchen - dining - lounge all in one with bi-folds opening out onto the garden. Accessible from the entrance hallway is a study which can be utilised as bedroom four if required, and a w/c.

The recently added loft conversion now adds a first floor featuring a large primary bedroom suite with dressing room including very cleverly placed windows offering the solent views down through the harbour to the Spinnaker Tower of Portsmouth. There are two further bedrooms and a modern four piece bathroom suite on this level.

Externally there is a front driveway for parking for four vehicles easily off road. The large rear garden wraps around the side of the property too offering plenty of outdoor space which is south west facing so an abundance of sunshine throughout the day.
