Referral Fees.

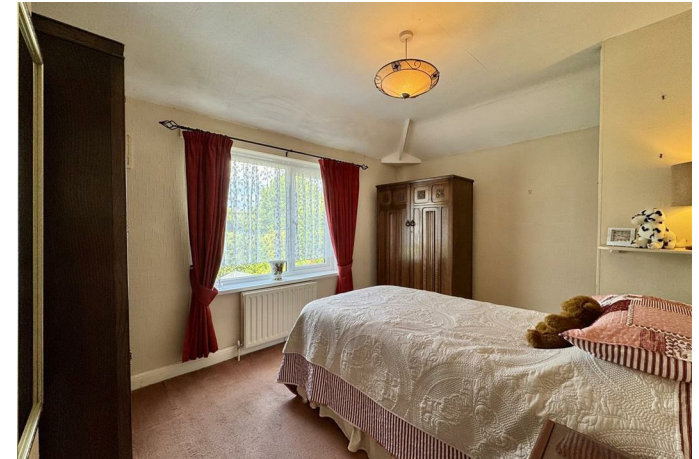
