This very spacious five bedroom, mid terraced property offers an ideal investment opportunity with tenants in situ until June 2026.

The property is spread over two floors with a bay fronted bedroom, living room, kitchen, shower room and conservatory to the ground floor. There are four bedrooms and a main bathroom to the first floor.

Ideally located within walking distance of the Christchurch University, city centre, shops and restaurants. Canterbury East train station and main bus station are also within walking distance with regular services available to London, Ashford and beyond.

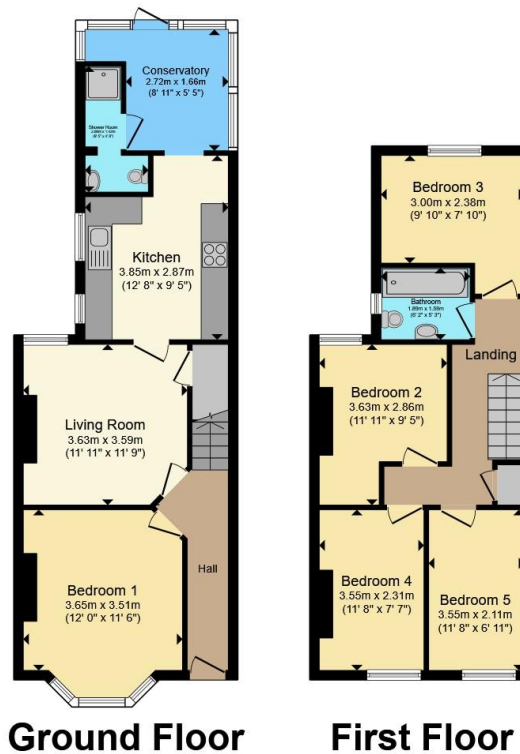
