A large lateral apartment, extending to just under 850 square feet across the top floor of the desired Bishops Park Mansions, this charming apartment combines modern finishes amongst period features.

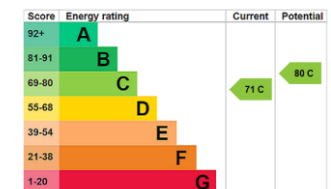

The property boasts a large living/reception room, with a log burner connected into the original chimney breast a period feature & the focal point of the room. The room is south facing, overlooking the tennis courts to the front. The kitchen/dining area boasts a good amount of storage cupboards and sufficient worktop space for a small family. The room also benefits from well-maintained integrated appliances, dedicated dining area & views over the developments well regarded communal gardens.
