Outside

The property benefits from off road parking located just off the road with a shared pathway leading to the front garden. The front garden is mainly gravelled with flower and shrub beds, gate to the side with pathway leading to the rear garden.

To the rear is an enclosed large garden with views over local farmland and towards Exmoor, the garden comprises laid to lawn, flower and shrub beds, decked veranda, timber summerhouse and garden shed, vegetable plot, oak tree. The garden is bordered by fencing and is southern facing.

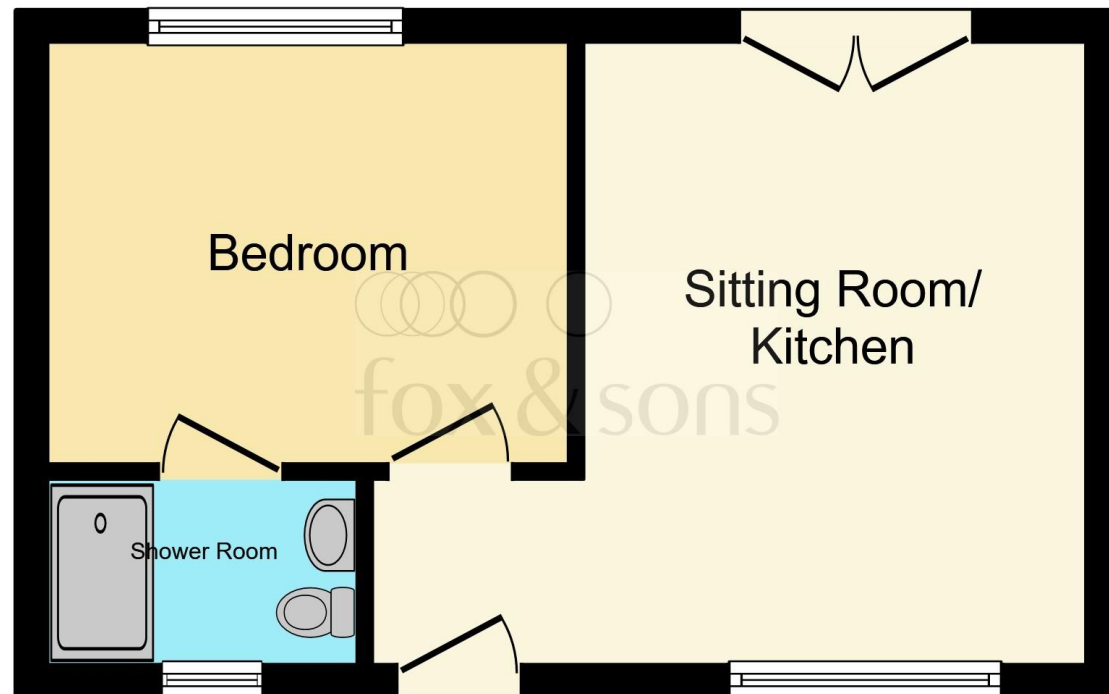
Location

Cleeve Park is a tranquil woodland park development suitable for full time occupiers or as holiday homes and is situated approximately half a mile from the sea front at Blue Anchor, two and a half miles from the village of Carhampton and approximately five miles from the coastal resort of Minehead with shopping, banking and recreational facilities. The county town of Taunton is approximately nineteen miles to the east with main line rail connections and access to the motorway network via junction 25 of the M5. For those who enjoy exploring the countryside, the Exmoor, Quantock and Brendon hills and many other beauty spots are all close at hand.
