Location...

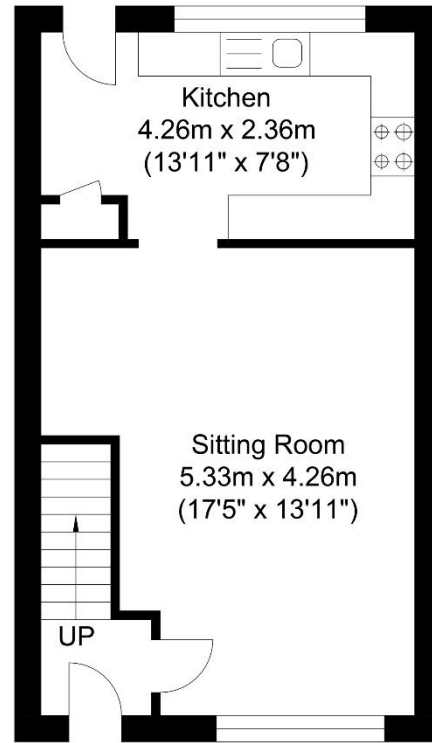

Scenic walks can also be found within moments of the property along the former Railway cutting. There is also a regular local bus service with services to Lewes and Brighton.

The High Street is just a 20-minute walk (source Google Maps), and Lewes Mainline Railways Station is a little further with direct services to London, Brighton and Gatwick.

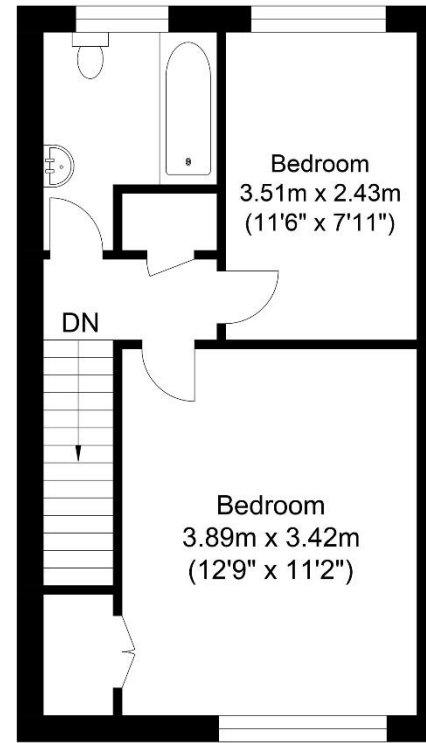
