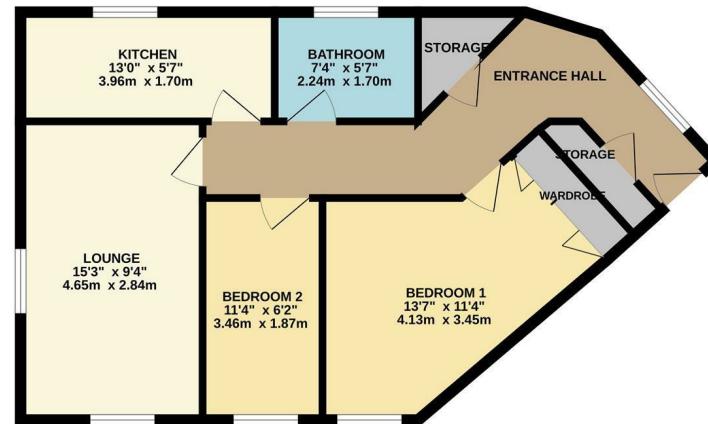

Other benefits include a telephone entry system, UPVC double glazed windows fitted in 2019 and multiple storage cupboards. Turnors is found just of Haydens Avenue, with Harlow Town Park and schools within walking distance. The property is currently tenanted, achieving a monthly rental income of £1400 per month.
