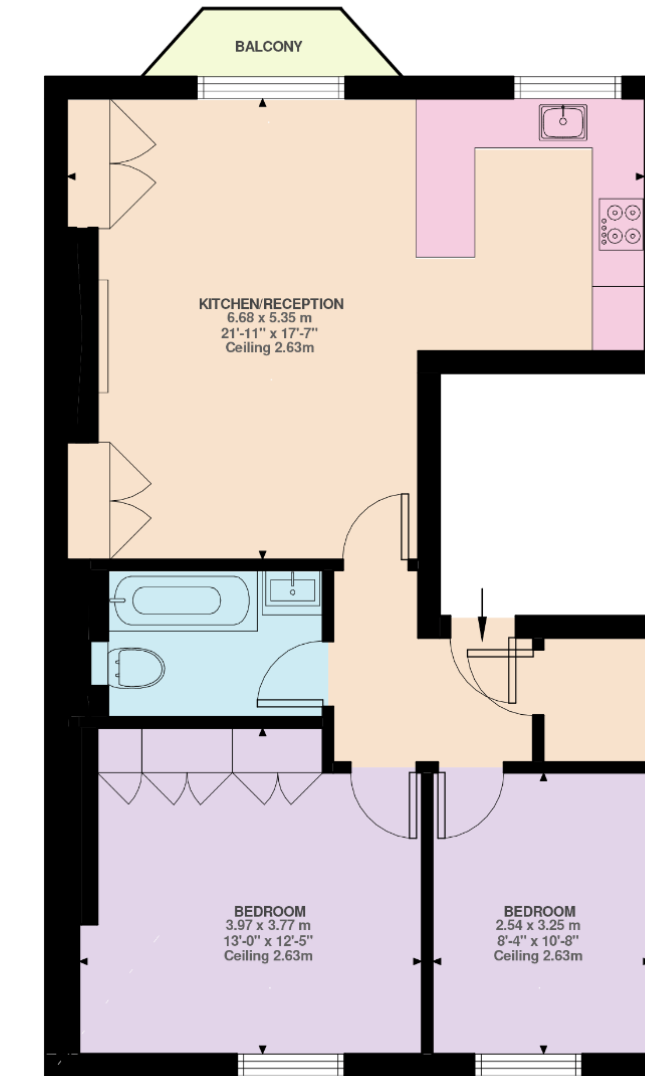


SPANNING APPROXIMATELY 704 SQ FT
