### **Entrance Porch**

Two single-glazed doors - one to front one to back and double-glazed composite door leads into the hall.

### **Lounge**

Double-glazed window to front, radiator, and a log burner.

### **Kitchen/Dining Room**

Fitted kitchen with the range of wall and base cupboards, work tops, sink, electric oven, gas hob, cooker hood, tiling to the walls, plumbing for a washing machine, and three double-glazed windows.

### **Landing**

Stairs from the lounge, access to the loft and a radiator.

### **Bedroom One**

Double-glazed window to front, fitted wardrobe and a radiator.

### **Bedroom Two**

Double-glazed window to rear, radiator and a built-in bed with storage.

### **Bedroom Three**

Double-glazed window to rear and a radiator.

### **Bathroom**

Double-glazed window to side, radiator, walk-in shower, wash hand basin, WC, mermaid board and tiling to the walls.

### **Rear Garden**

Paved and graveled areas with timber multifunction outbuilding with a door and a window, timber fencing forming boundary.
