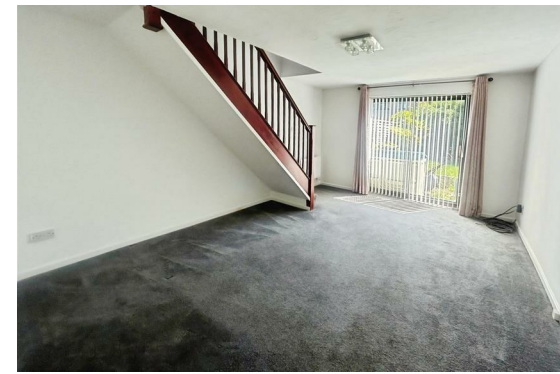
The family bathroom is thoughtfully designed, complete with a shower over the bath, catering to both quick morning routines and leisurely evening soaks.
