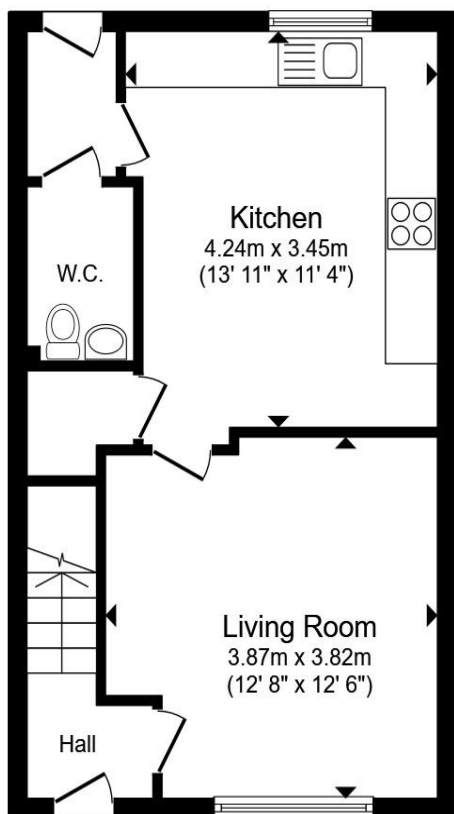

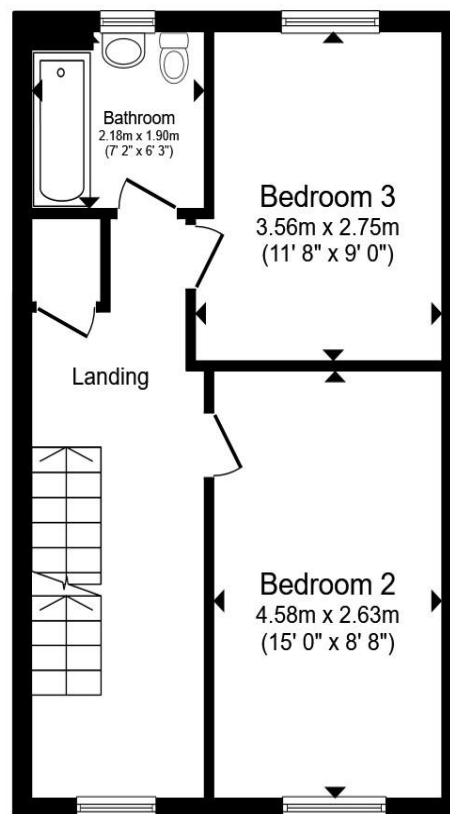

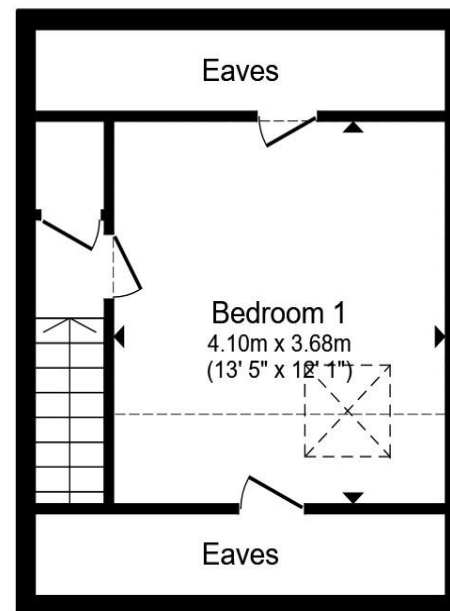




Ground Floor
