Whilst the 'Wellesley', the town's unique 1930s cinema offers entertainment in the evening. 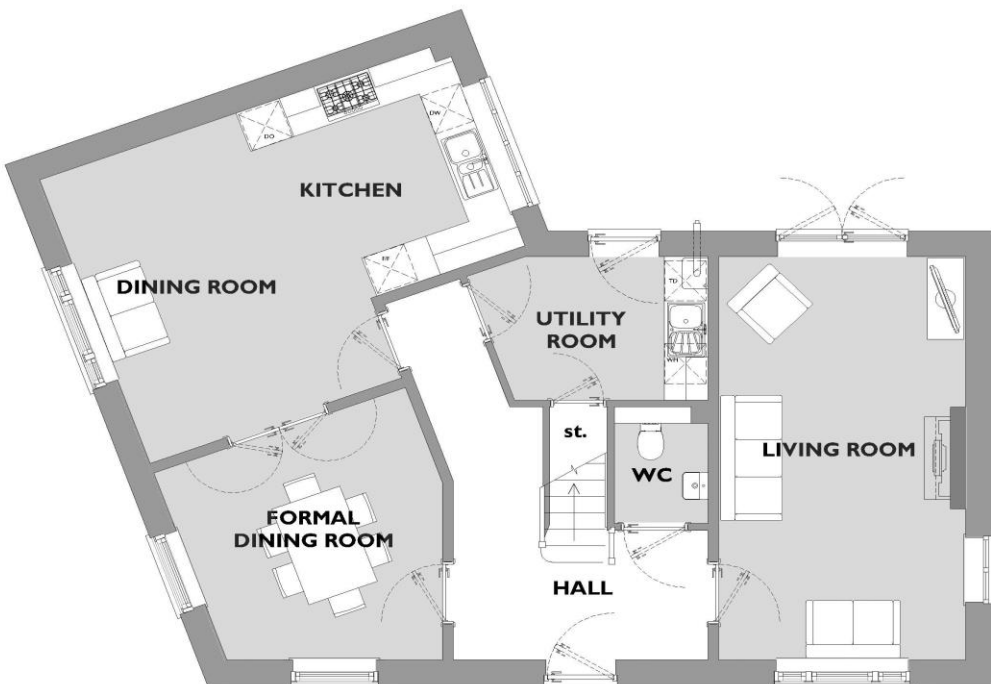

GROUND FLOOR PLAN

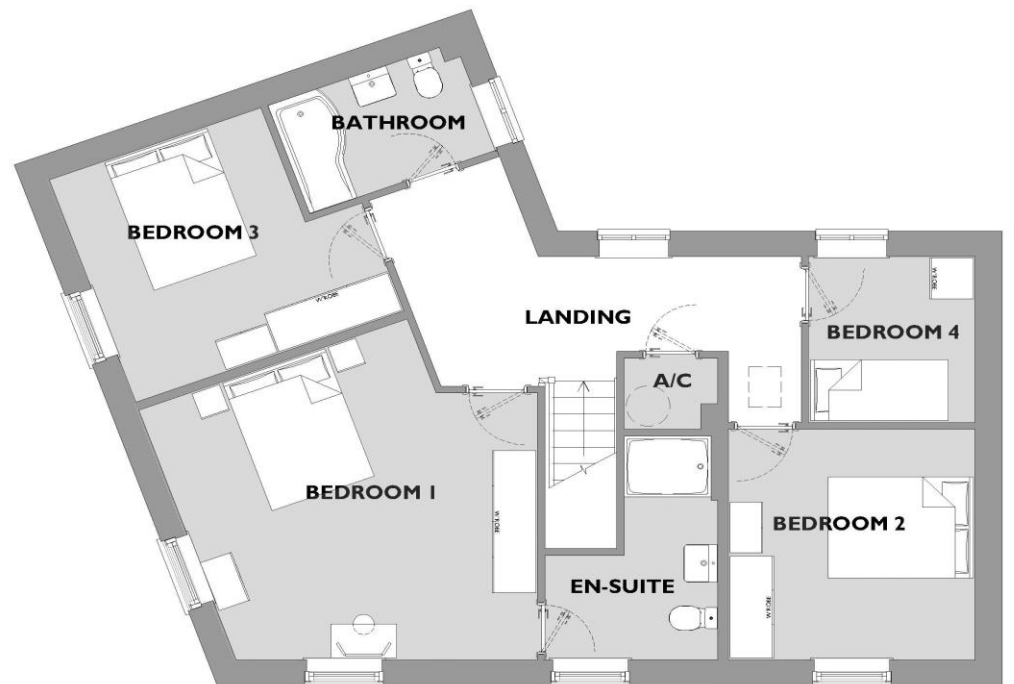
