Caerau is an attractive former mining village set within the Llynfi Valley, approximately two miles north of Maesteg town centre. Surrounded by dramatic hillside scenery, forestry and open countryside, the area offers a strong rural feel while remaining within easy reach of local amenities. Positioned close to the boundary between Bridgend County Borough and Neath Port Talbot, Caerau enjoys access to neighbouring communities including Croeserw, Cymmer, Dyffryn and Nantyllyllon. The surrounding landscape makes it particularly appealing for those who enjoy outdoor pursuits, with excellent opportunities for country hacking and riding routes for local equestrian enthusiasts.

From Junction 34 of the M4 Motorway, proceed to the roundabout and take the first exit. Continue onto the A4063 and follow the road for approximately 9.3 miles towards Maesteg. Remain on the A4063 through the following roundabouts, taking the third exit at the first roundabout and the first exit onto Maesteg Road/A4063 at the next. Continue along the A4063 before turning right onto Bridge Street, then left onto Castle Street/B4282. Follow Castle Street as it continues through Maesteg, becoming High Street/A4063. Turn right onto Library Road, then turn left to remain on Library Road. Continue onto Greenfield Terrace before turning left onto Pleasant View. The property, 2 Llynfi View, Maesteg, CF34 0RE, will be found on the right-hand side.

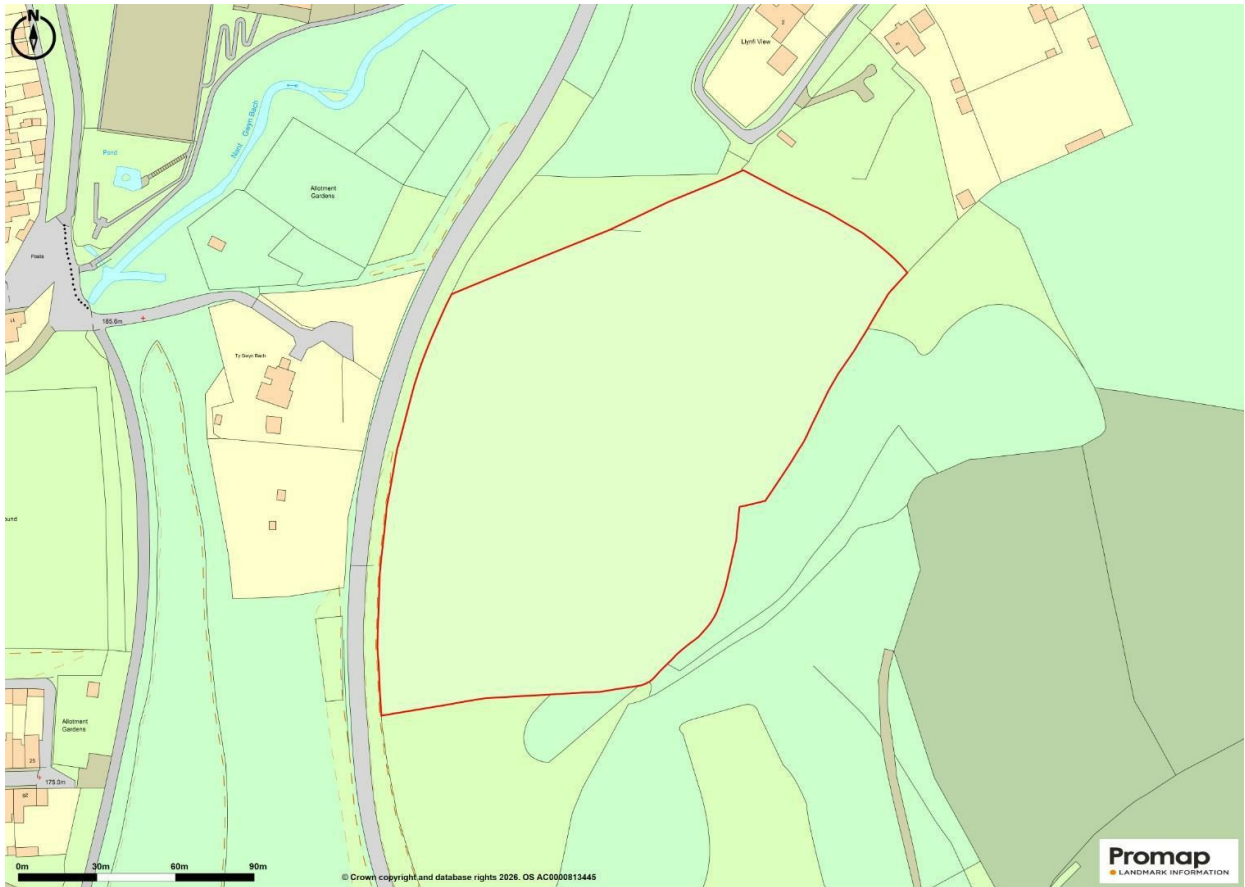
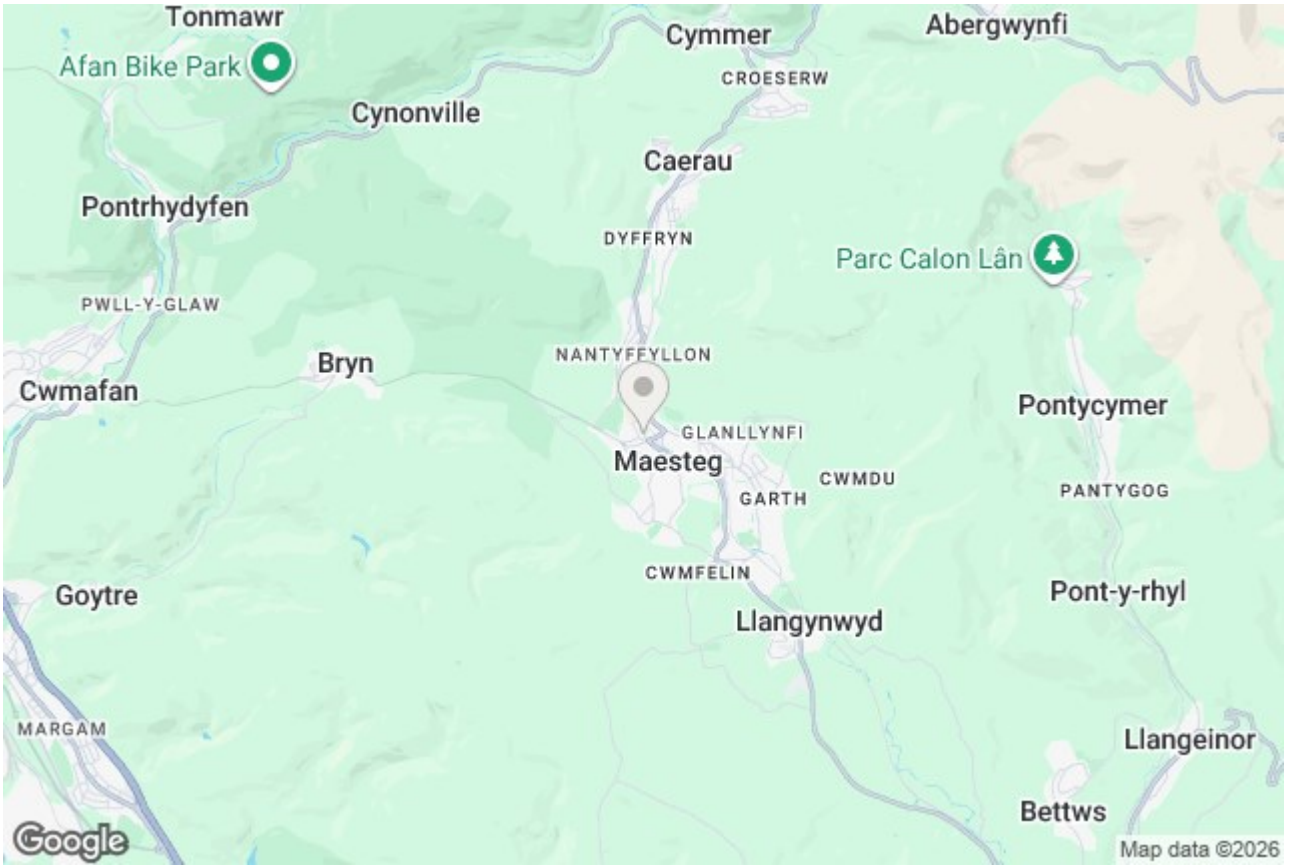
