KITCHEN 3.81m (12'06") x 3.34m (10'11") With a pair of double glazed sash windows overlooking the rear garden and enjoying a southerly aspect with views to Sidmouth Rugby Ground. A fitted kitchen comprising a range of floor standing and wall mounted cupboards with dark coloured wood doors, chrome coloured handles, grey work surfaces and white splashbacks. Stainless steel sink with single drainer. Space for electric oven with stainless steel chimney style extractor over. Space for freestanding fridge/freezer. Thermostatically controlled radiator. Ideal gas fired combi boiler. Gas meter and gas isolation valve.
