Situation

Extending to around 1.02 acres (0.41ha) Consisting of woodland with two ponds and some small timber and galvanised iron storage sheds in need of repair. There is a gateway leading directly off the B3344 allowing good access to the property. The property has been used for many years by a beekeeper although the hives are now removed, prior to this it was the garden to a local school. The boundaries are a combination of stone retaining walls and fences.

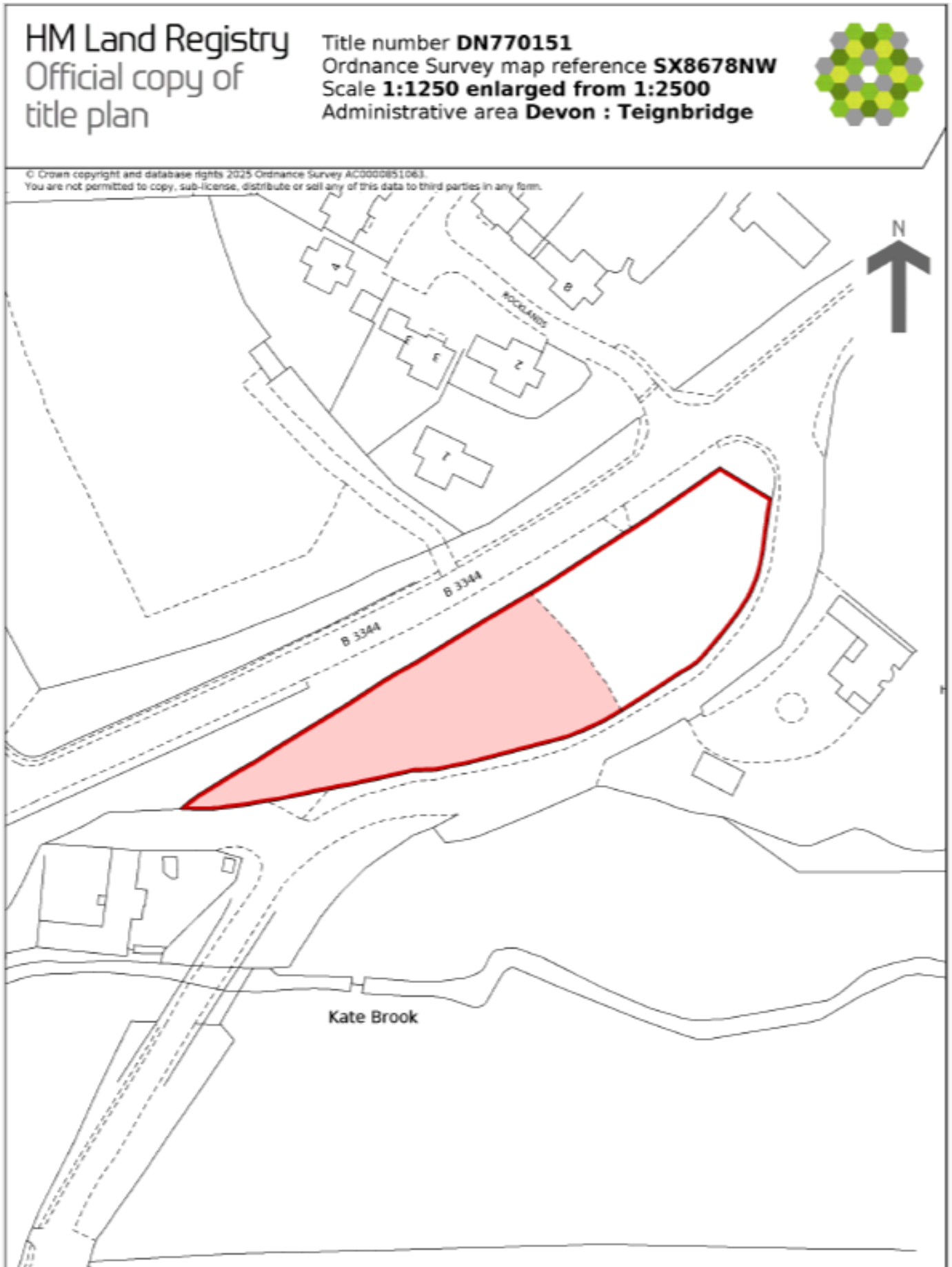
