Situation

Chitterne is a small remote village nestling in the folds of chalk on Salisbury Plain. It is a close-knit village with a vibrant community spirit, a pub (The King's Head), a village hall, and a sports field. While remote, it benefits from nearby larger villages (Codford, Heytesbury) for shops and services, and good road links to Salisbury, Bath, and London via the A36/A303.

It is recommended you check your web browser will allow you to bid in good time as some browsers' security can block the ability to bid. We recommend using Google Chrome when possible.

We offer property for sale by immediate, unconditional contract. This means that the fall of the electronic gavel constitutes an exchange of contracts between the buyer and seller. Both parties are legally bound to complete the transaction usually within 20 working days following the close of the auction but this will be confirmed within the legal documentation.


Legal Pack


Ground Floor Flat
