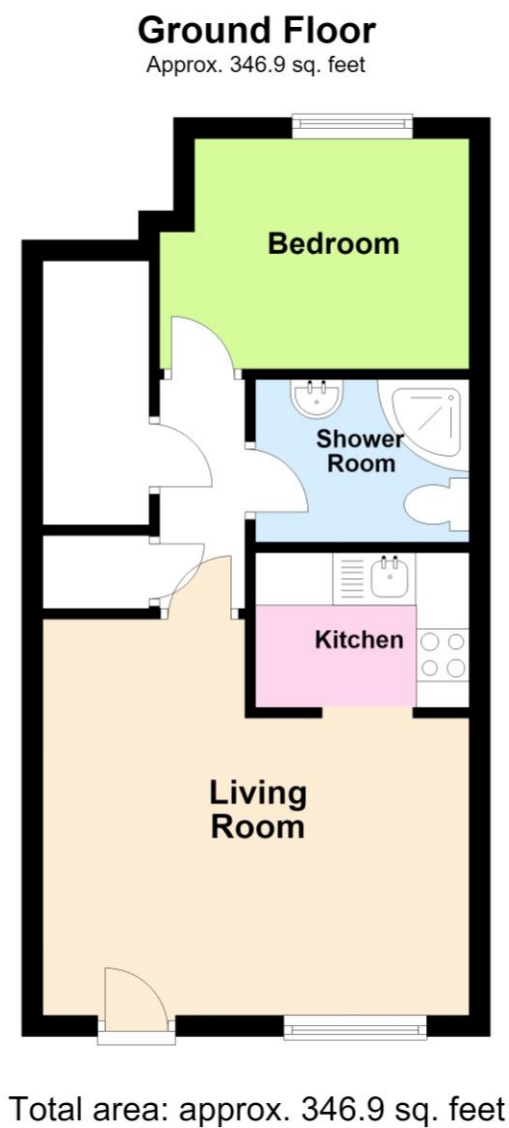

Situated in the 'Old Village' of Finedon and offered in excellent condition throughout is this modern one bedroomed ground floor apartment with features to include electric heating, modern kitchen with built in appliances, modern shower room and offers allocated off road parking for one car and no upward chain. The accommodation briefly comprises living room, kitchen, bedroom, shower room and allocated off road parking.
