DRIVEWAY & SINGLE GARAGE

The property further benefits from an enclosed rear garden, with additional gardens to the front and side, a single garage and a driveway.



LOCATION

Old Barn Court is a small residential development situated within the village of Ludford, positioned on the edge of open countryside. The village offers a rural setting while still providing convenient access to Market Rasen, which offers a range of local amenities including shops, schools, leisure facilities and a railway station. The A46 is also within easy reach, providing road links towards Lincoln and the wider Lincolnshire area

ACCOMMODATION
