Broughton Lodge, Grange-Over-Sands

Set in a peaceful location in Field Broughton, Grange-over-Sands, this charming apartment in a converted 1800s Georgian manor house blends character with countryside living. The village offers a tranquil setting yet is within easy reach of local amenities and Michelin-star restaurants.

Downstairs, the kitchen is equipped with an electric hob, twin ovens, and fridge. There is a separate fridge freezer under the stairs too. The spacious drawing room features an elegant arched doorway, two windows flooding the space with natural light and offering views across the surrounding fields.

Upstairs, there are two double bedrooms and a versatile vestibule space. The bathroom has a four piece suite, complemented by a separate WC. The loft provides full boarding for additional storage.

Outside, residents enjoy several acres of communal gardens with mature trees, plus designated cellar storage and off-street parking at the sides. The apartment is set within a friendly, long-standing community, making this a welcoming home in a serene countryside environment.

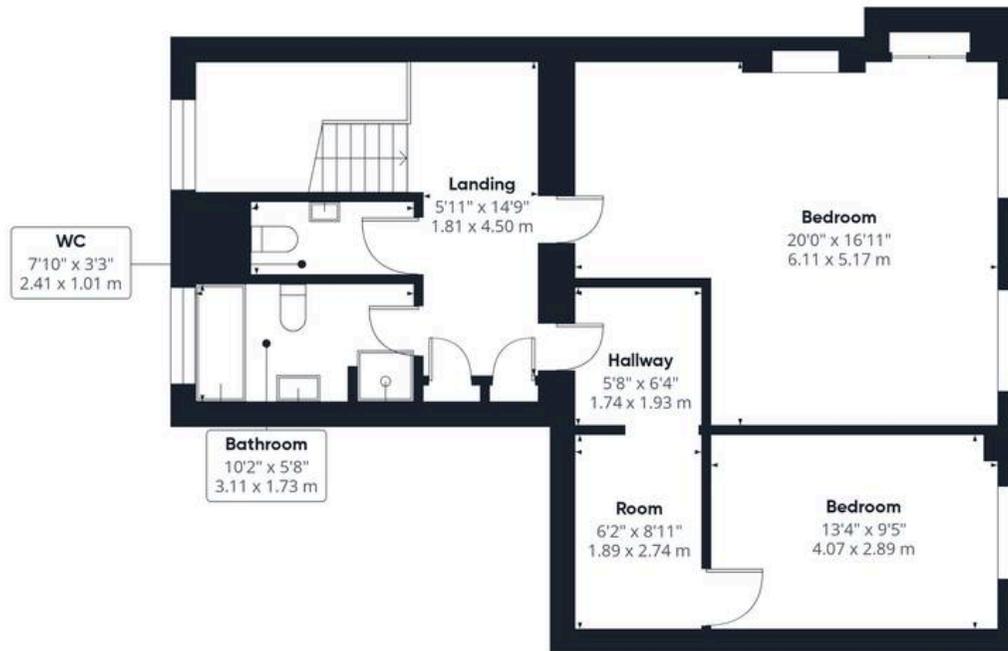
IDENTIFICATION CHECKS
