LOCATION

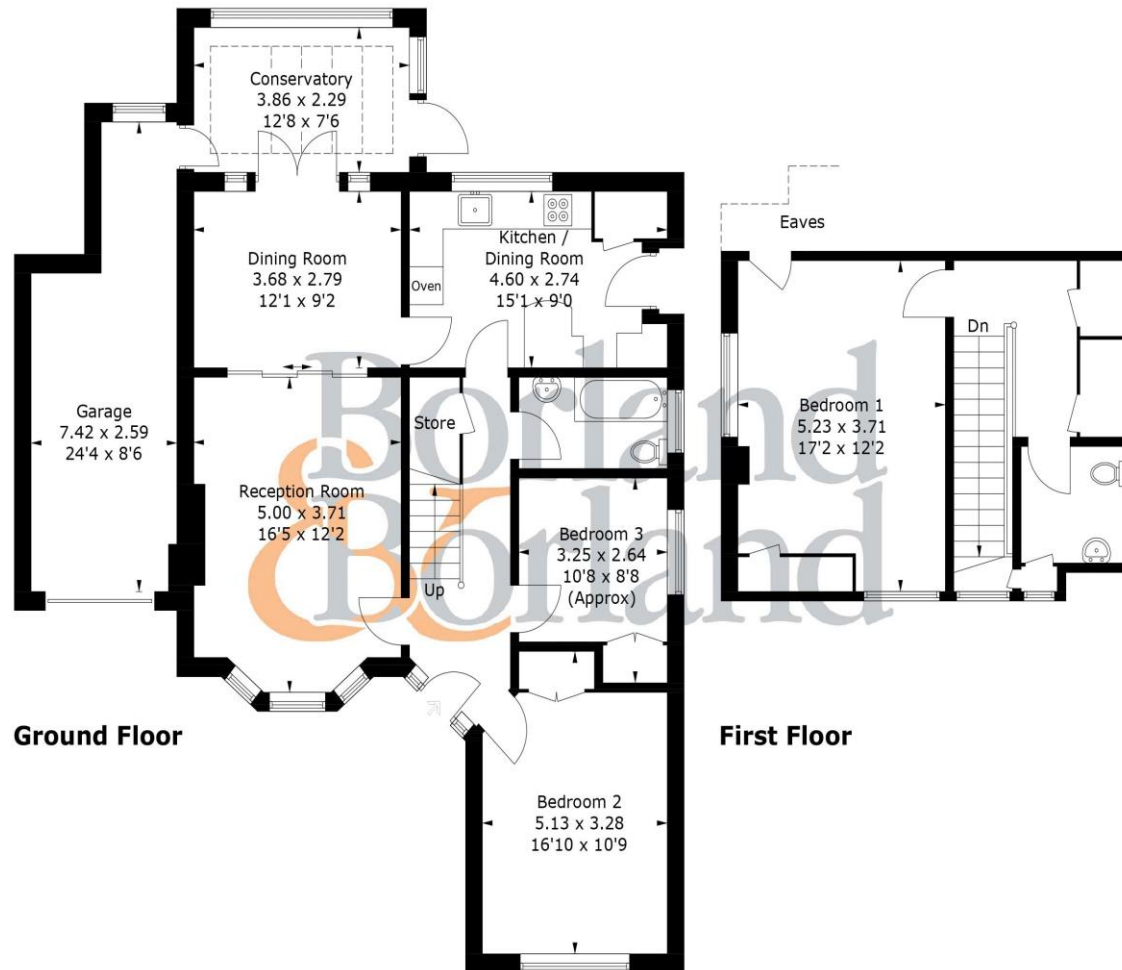
