



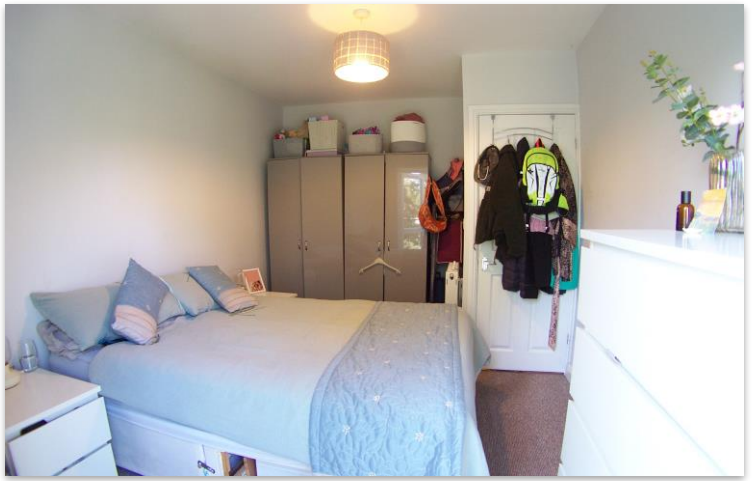

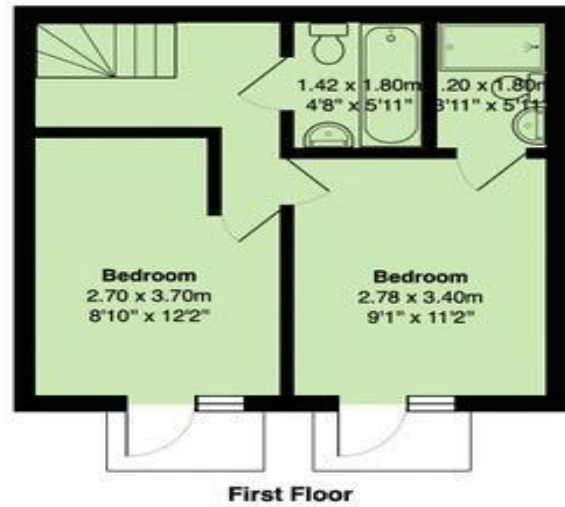

Tenant application process
