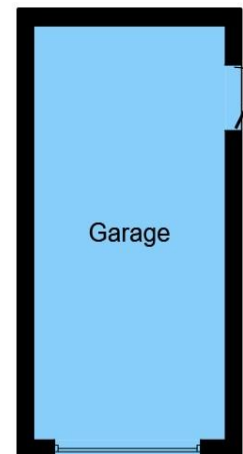




Ground Floor
