



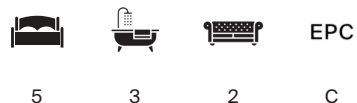

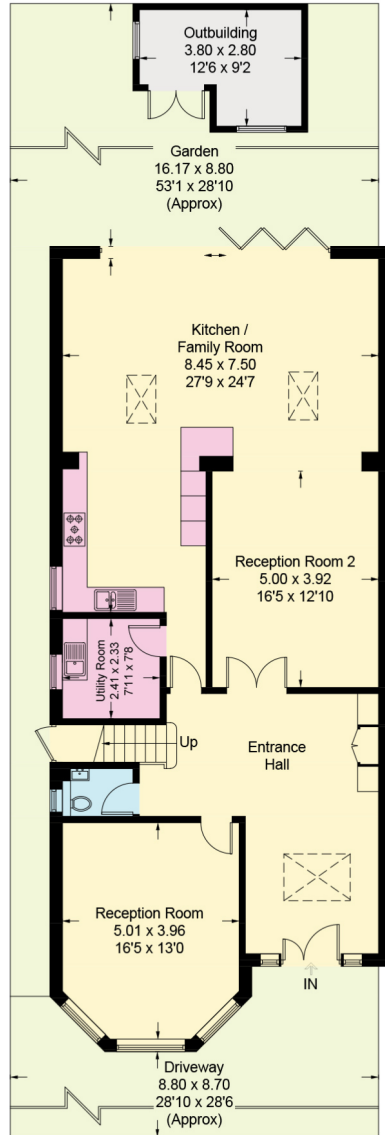
The open-plan living and dining area forms the heart of the home, ideal for both everyday living and entertaining, complemented by a dedicated home office for flexible working.

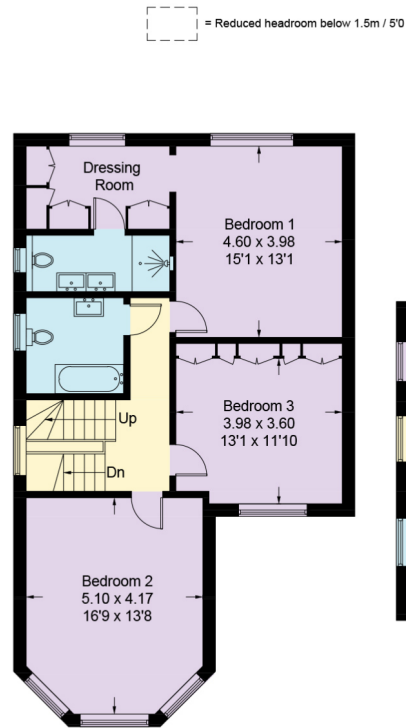




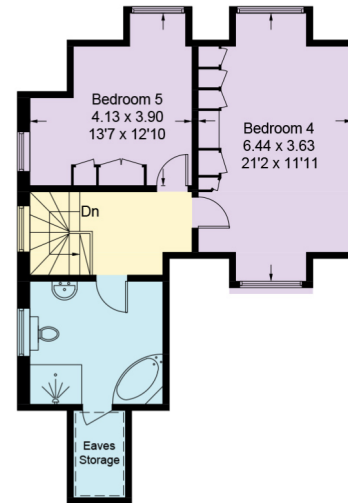




Ground Floor
