The Laurels is an extended detached period house of brick and tile construction positioned on a large plot, situated in a desirable residential location. The property would benefit from some upgrading / refurbishment but offers spacious accommodation across two floors. The ground floor is set out to two reception rooms, a kitchen and shower room and the first floor having three double bedrooms. The property is gated and provides ample off road parking, a detached garage, car port and summer house.

Wrockwardine Wood is a popular and well established residential area of central Telford, and benefits from having a good range of local amenities close by, including a parade of shops at Donnington, an Asda supermarket/petrol filling station, medical centre and pharmacy, and both primary and secondary schools. There is also the Cockshut country park nearby as well as a leisure centre, tennis centre with indoor and outdoor courts, athletics track and all weather pitches.

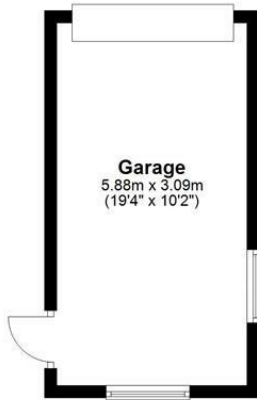
