Outside, there is a low maintenance rear courtyard and a garden with mature trees surrounding the area making it feel quiet and private.

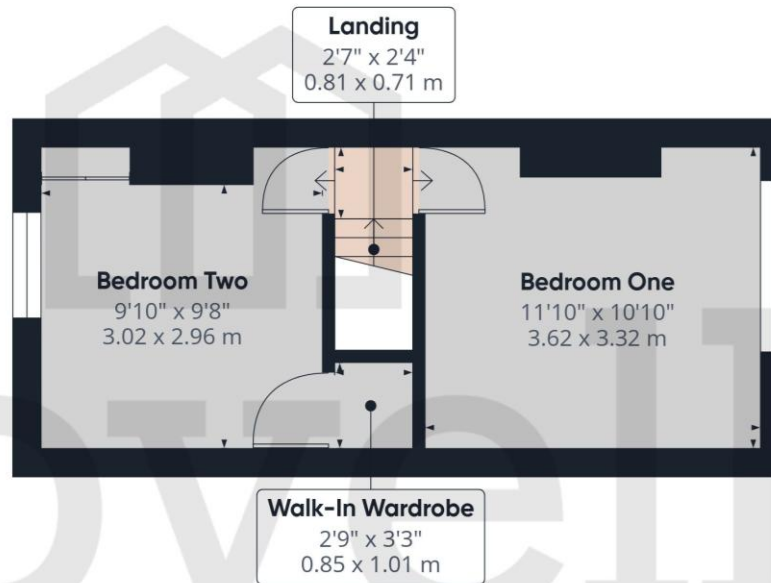
