This townhouse is ideally located, with excellent public transport links nearby and easy access to local parks, making it well-suited to commuters and those who enjoy outdoor activities.

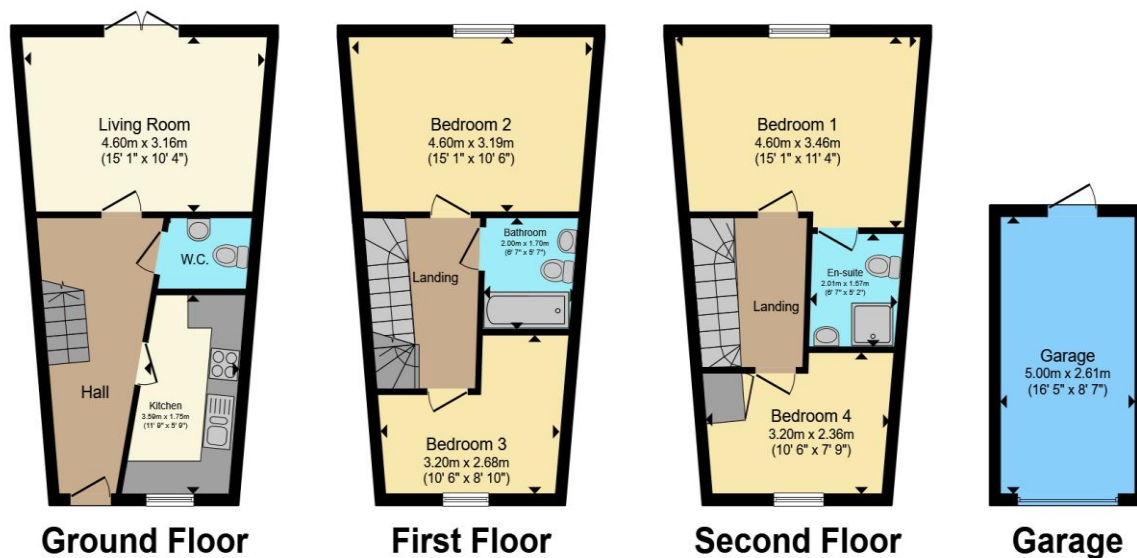
