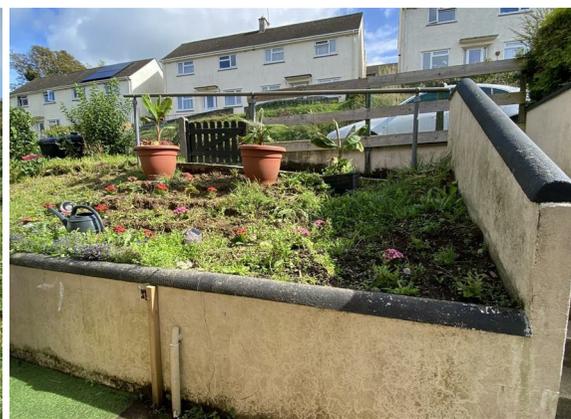

Turning staircase up to the

LANDING & HALLWAY:

Linen cupboard with shelving. Radiator. Doors off

LIVING ROOM:

16'5 x 10'6 (5.00m x 3.20m)

uPVC double glazed windows to the rear with countryside views. Radiator. Open fireplace with tiled mantle and hearth.

PRINCIPAL BEDROOM:

13'3 x 9'3 plus door recess (4.04m x 2.82m plus door recess)

uPVC double glazed window to side. Radiator.

BEDROOM TWO:

uPVC double glazed window to side. Radiator.
