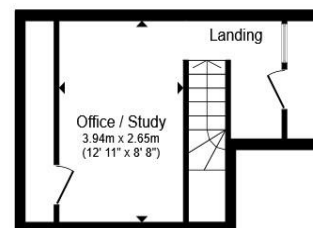




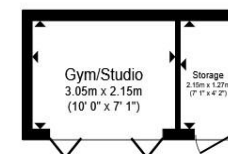
Ground Floor
