ENTRANCE

Original wooden door to:

LOUNGE

Window to front. Built brick feature fireplace with wood burning stove, radiator, door to kitchen.

KITCHEN/DINING ROOM

Fitted with a range of wall mounted and floor standing units with work surface over, stainless steel single drainer sink unit with mixer tap, cooker point, plumbing for washing machine, radiator, stairs rising to first floor, opening to rear lobby and window to rear.

REAR LOBBY

Half glazed door to rear courtyard and door to bathroom.

BATHROOM

Enamelled steel panelled bath with mixer tap and shower attachment, hand wash basin, low level w.c, part tiled walls, radiator, window to rear.

LANDING

Access to loft space, doors to bedrooms.

BEDROOM ONE

Window to front. Radiator.

BEDROOM TWO

Window to rear. Airing cupboard housing gas combination boiler, radiator.

REAR COURTYARD

A small paved area which provides access to the pathway leading to the garden.

REAR GARDEN

Situated just a short walk away the garden is a wonderful secluded area which is mainly laid to lawn with ornamental pond, enclosed by fencing and hedging, outside tap, outside lighting and access to the studio.

STUDIO

A detached timber studio which is accessed via glazed double doors with a timber decked veranda and power and lighting. The studio would make an ideal home office.
