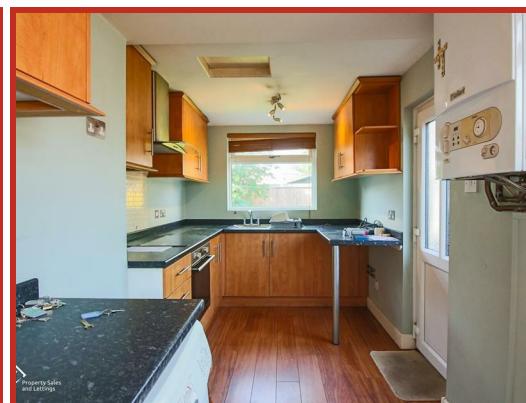
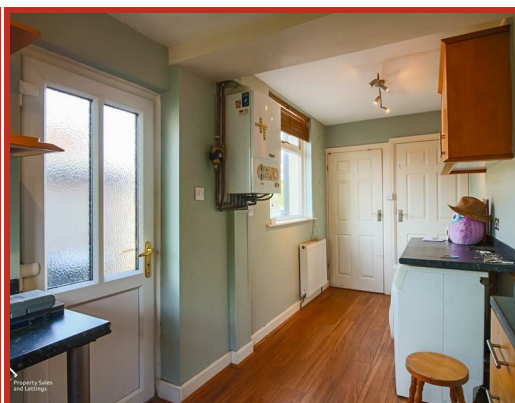
Metal door to side, open out doors to front, single glazed window, concrete floor, electric.

Front

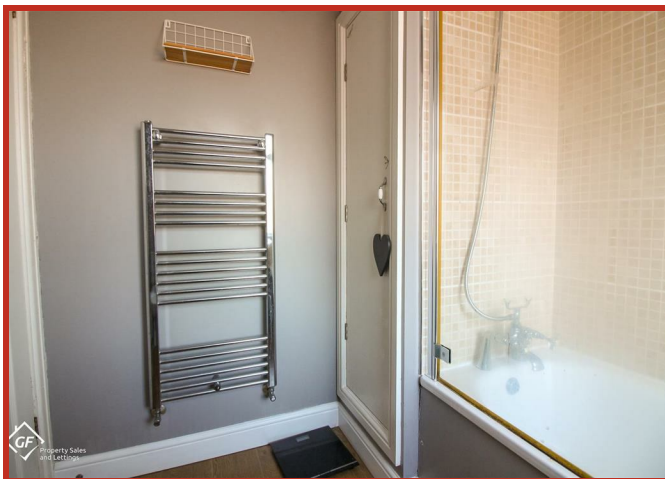
Gravel driveway for multiple cars, paved path to front door and side, astro turf laid lawn to front.

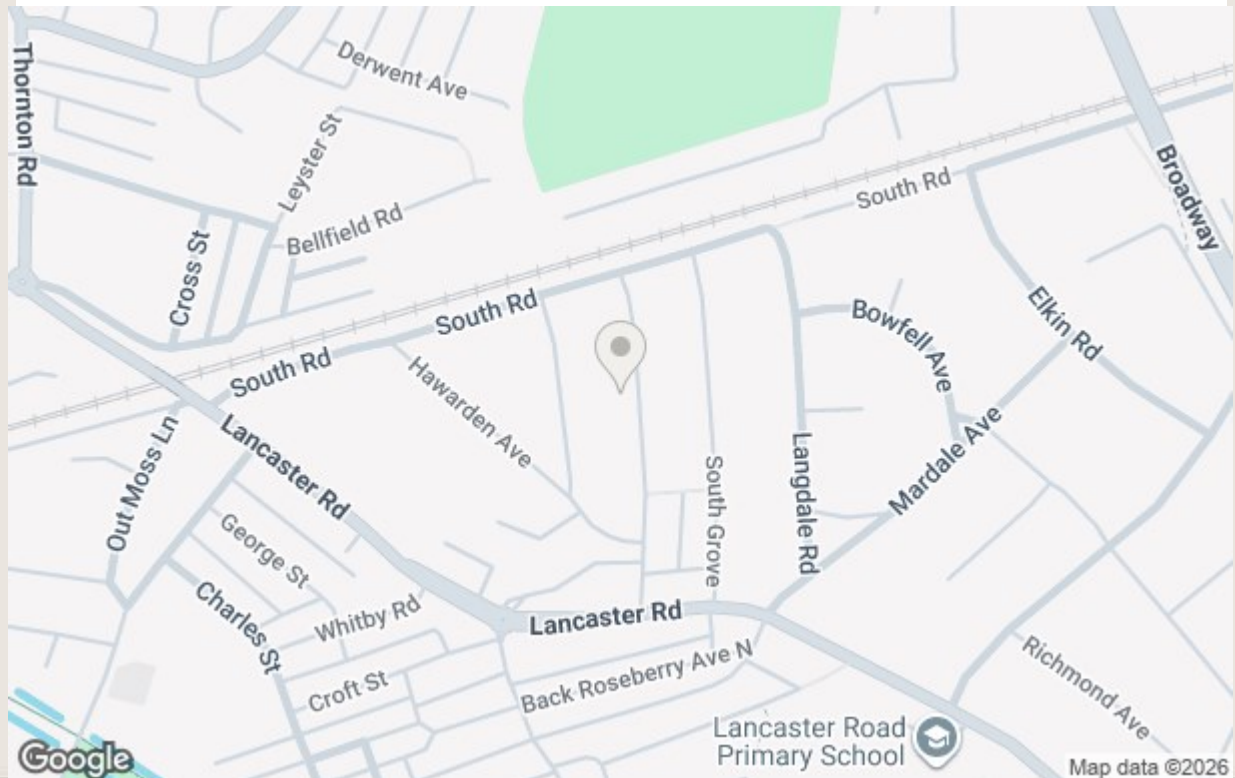
