Sold via modern method of auction, this two-bedroom mid-terrace property is ideally situated close to Keighley town centre, with convenient access to local amenities and bus routes. Offering excellent potential, the property would suit first-time buyers or investors alike.



The ground floor comprises a spacious living room featuring wood-effect laminate flooring and a fireplace, alongside a kitchen with lino flooring and space for a washing machine and fridge freezer. The kitchen would benefit from modernisation and offers scope for reconfiguration.

A useful large cellar provides additional storage space and offers potential for conversion, subject to the necessary permissions and regulations.

To the first floor are two bedrooms, including one double bedroom and one single bedroom, together with the house bathroom. The bathroom is fitted with a three-piece suite, including a shower over the bath, and benefits from useful shelving and storage space.

Externally, the property enjoys a small front yard and a paved rear yard with a shared outhouse, ideal for bin storage.
