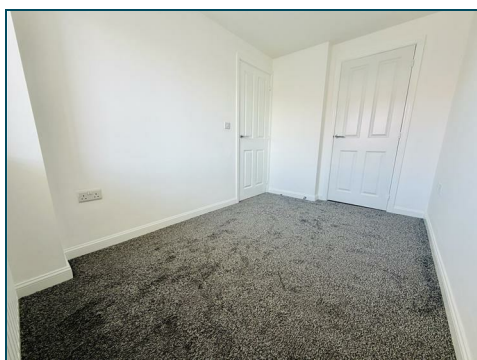

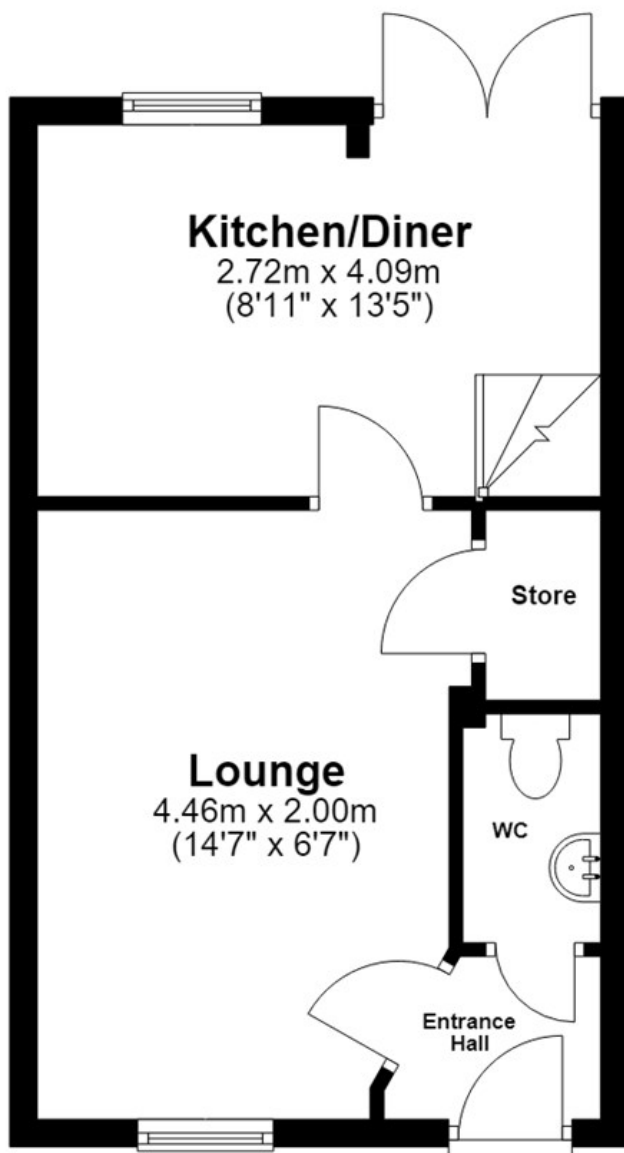

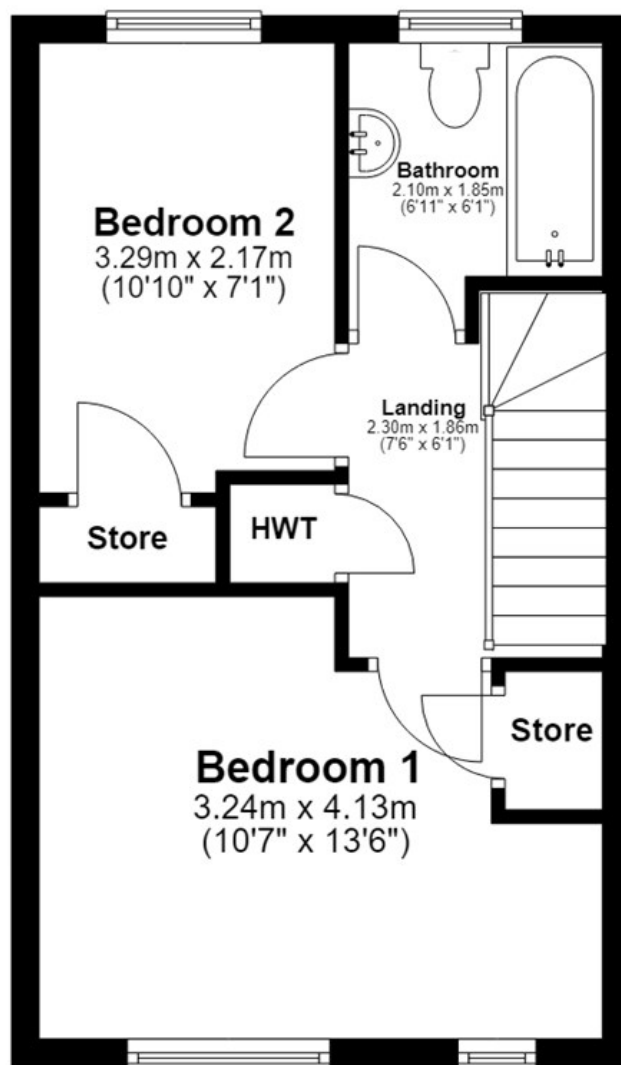
Ground Floor
