INTRODUCTION

This five bedroom detached house is situated in a prominent position on the popular West Mead development, boasting a double garage and a gated driveway. The property is built in a cottage style with a thatched roof, is within level walking distance of Bridport town and its amenities, and has wonderful countryside walks from the house itself.

THE PROPERTY

The property is conventionally arranged around a spacious entrance hallway, with the living room to one side with a focal point of an exposed brick fireplace equipped with a gas coal effect stove. The room features exposed beams and has French doors onto the covered paved terrace. The kitchen/dining room is fitted with a comprehensive range of wall and base units with space for all the essential appliances, and opens into the generously proportioned conservatory. Off the kitchen is a useful utility room and an internal door into the double garage. Also to the ground floor is a further reception room, currently utilised as a study but could be a separate dining room if required.

Upstairs, accessed off the spacious landing, are five bedrooms, two of which have an ensuite shower room, and a family bathroom. The principal suite is of particular note, with a spacious ensuite and a large walk-in wardrobe.

OUTSIDE

The garden is designed for ease of maintenance, with a covered paved terrace with raised flower beds immediately adjoining the living room, ideal for outside entertaining. The brick paved driveway leads to the double garage, currently divided into a workshop space and a home gym. There is a small area of lawn beyond the driveway.

SERVICES

Mains gas, electricity, water and drainage. Gas fired central heating.

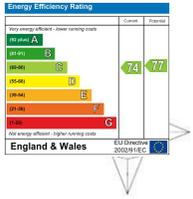
SITUATION

The property is situated on the Western side of Bridport in a small development of similar cottages and houses. Bridport is a bustling market town with a history of rope-making and is close to the World Heritage Jurassic coastline. It has a variety of independent shops, supermarkets, public houses and restaurants catering for a range of tastes and excellent arts and music events. West Bay has its harbour and beaches and a variety of small businesses catering for everyday needs. Bridport is conveniently placed for Dorchester and Weymouth to the east and Axminster to the west. Walking, water sports, golf and riding opportunities are plentiful in the area and there are several beaches to choose from. Communication links are good with road links along the A35 and mainline stations at Maiden Newton, Dorchester, Axminster and Crewkerne.
