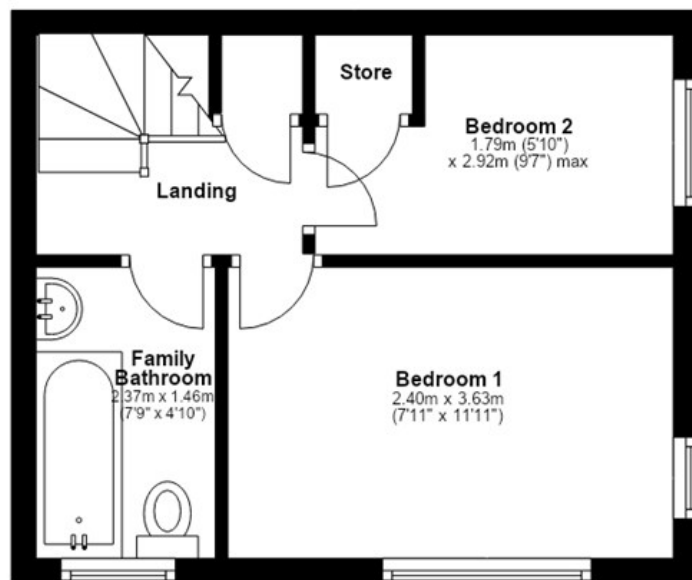
Ground Floor
